

**KIRKLEES COUNCIL
(SPEED LIMIT) (No. 103) ORDER 2017**

**A629 PENISTONE ROAD, SHELLEY – A629 LANE HEAD ROAD SHEPLEY -
A629 PENISTONE ROAD BIRDSEDGE/HIGH FLATTS – B6116
HUDDERSFIELD ROAD, HUDDERSFIELD**

The Council of the Borough of Kirklees ("the Council") in exercise of their powers under Sections 81, 82 (2) and 84 (1) (a) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order which relates to lengths of road at Shelley, Shepley, Birds Edge and High Flatts in the Kirklees Metropolitan District.

SPEED LIMITS

1. No person shall drive any motor vehicle at a speed exceeding 40 mph on the length of the road specified in the First Schedule Column1A and 30 mph on the length of the road specified in the First Schedule Column1B

REVOCATIONS

2. The Order listed in the Column 1 of the Second Schedule shall hereby be revoked to the extent set out in Column 2 of the Second Schedule.

GENERAL

3. Except where the context otherwise requires, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order and any reference to a numbered Schedule is a reference to the Schedule bearing that number in this Order.
4. Any reference to a Statute or Statutory Instrument in this Order shall include reference to any subsequent Statute or Statutory Instrument where the context requires it.
5. This Order shall come into effect on the 25th day of May Two Thousand and Eighteen and may be cited as the "Kirklees Council (Speed Limit) (No.103) Order 2017".

A629 Penistone Road	From a point 219 metres South East of the projected South Eastern kerb line of Birdsedge Lane to a point 140 metres South East of its junction with the projected South Eastern kerb line of Green Lane

<u>Name of Road/s</u>	<u>Length Affected</u>
A629 Lane Head Road	From a point 107 metres North West of the projected North Western Kerb line of Carr Lane for a distance of 386 metres in a North Westerly / Northerly direction

<u>Name of Road/s</u>	<u>Length Affected</u>
B6116 Huddersfield Road, Kirkburton	From a point 25 metres South East of the projected South Eastern Kerb line of Queens Way to the projected North West building line of number 49 Huddersfield Road.
