

**KIRKLEES COUNCIL
(SPEED LIMIT) (NO. 110) ORDER 2021
CUMBERWORTH ROAD AND PONKER LANE, SKELMANTHORPE
(30MPH SPEED LIMIT AND 60MPH SPEED LIMIT)**

The Council of the Borough of Kirklees ("the Council") in exercise of their powers under Sections 81, 82 (2) and 84 (1) (a) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order which relates to a lengths of road at Cumberworth Road and Ponker Lane, Skelmanthorpe in the Kirklees District.

SPEED LIMITS

1. No person shall drive any motor vehicle at a speed exceeding 30 mph on the length of the road specified in the First Schedule
2. No person shall drive any motor vehicle at a speed exceeding 60 mph on the length of the road specified in the Second Schedule

REVOCATIONS

3. The speed limit provisions referred to in the Third Schedule shall hereby be revoked

GENERAL

4. Except where the context otherwise requires, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order and any reference to a numbered Schedule is a reference to the Schedule bearing that number in this Order.
5. Any reference to a Statute or Statutory Instrument in this Order shall include reference to any subsequent Statute or Statutory Instrument where the context requires it.
6. This Order shall come into effect on the 5th day of December Two Thousand and Twenty Two and may be cited as the "Kirklees Council (Speed Limit) (No.110) Order 2021".

30mph Speed limit

Name of Road	Length affected
Cumberworth Road, Skelmanthorpe, Huddersfield	From the junction with Huddersfield Road southwest to a point 175m southwest of the junction with Dene Road
Ponker Lane, Skelmanthorpe, Huddersfield	From Cumberworth Road southwest wards for 55m.

SECOND SCHEDULE

60mph Speed limit

Name of Road	Length affected
Ponker Lane, Skelmanthorpe, Huddersfield	From 55m southwest of Cumberworth Road to the junction with Shelley Woodhouse Lane

Third Schedule

Revocations

- Ponker Lane 60mph speed limit (derestricted) from Shelley Woodhouse Lane to Cumberworth Road
- Cumberworth Road 60mph speed limit (derestricted) from Ponker Lane to a point 130m southwest of Dene Road
- Cumberworth Road 30mph speed limit from a point 130m southwest of Dene Road northeast wards to the junction with Huddersfield Road
