SECTION 1 OF THE ROAD TRAFFIC REGULATION ACT 1984 AND REGULATION 7 OF THE LOCAL AUTHORITIES TRAFFIC ORDERS (PROCEDURE) (ENGLAND AND WALES) REGULATIONS 1996

(TRAFFIC REGULATION) (NO. 27) ORDER 2021

The Council of the Borough of Kirklees ("the Council") in exercise of their powers under Sections 1, 2, and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order which relates to a length of road in the Dewsbury area in the Kirklees district:-

PART I

1. Interpretation

- 1.1. Save where the context requires, any reference in this Order to a numbered Article is a reference to the numbered Article bearing that number in this Order.

PART II

2. Prohibition of Pedestrians

- 2.1 Save upon the direction or with the permission of a police constable in uniform or of a civil enforcement officer no foot passenger shall proceed on the lengths of road specified in the Schedule to this Order
- 2.2 Nothing in Article 2.1 of this Order shall render it unlawful for any foot passenger to proceed in the length of road referred to in that Article if it is necessary for him or her to do so in connection with any building operation or demolition; the removal of any obstruction to traffic; maintenance improvement or construction of the road or the side of the road or of any of the lengths or parts of road so referred to; or the laying, erection, alteration or repair in or near the said road, the said side of road or any of the said lengths or parts of road of any sewer or of any main, pipe or apparatus for the supply of gas water or electricity or of any telegraphic line

PART III

3. General

- 3.1. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act or by or under any other enactment.

- 3.2. Any reference in this Order to a Statute or Statutory Instrument shall include reference to any re-enactment or replacement thereof.
- 3.3. This Order shall come into operation on the 7th day of March 2021 and may be cited as the "Kirklees Council (Traffic Regulation) (No. 27) Order 2021".
