KIRKLEES COUNCIL (TRAFFIC REGULATION) (NO. 11) ORDER 2018

The Council of the Borough of Kirklees ("the Council") in exercise of their powers under Sections 1, 2, 4 and 92 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order which relates to roads at Mirfield and Roberttown in the Kirklees District:-

PART I

1. <u>Interpretation</u>

1.1. Save where the context requires, any reference in this Order to a numbered Article is a reference to the numbered Article bearing that number in this Order.

PART II

2. <u>No right turn restriction</u>

2.1. No person causing a vehicle to proceed in a road specified in Column 1 of the Schedule to this Order shall, except upon the direction of a police constable in uniform or of a traffic warden, cause that vehicle on reaching the junction with the road specified opposite that road in Column 2 of the said Schedule to make a right turn into such road.

No left turn restriction

2.2. No person causing a vehicle to proceed in a road specified in Column 1 of the Schedule to this Order shall, except upon the direction of a police constable in uniform or of a traffic warden, cause that vehicle on reaching the junction with the road specified opposite that road in Column 2 of the said Schedule to make a left turn into such road.

PART III

3. General


- 3.1. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations made or having effect as if made under the Act or by or under any other enactment.
- 3.2. Any reference in this Order to a Statute or Statutory Instrument shall include reference to any re-enactment or replacement thereof.
- 3.3. For the avoidance of doubt, any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road or more than one parking place where the context requires it.

- 3.4 This Order or any provision within it may be modified or suspended by the Director of Place or other duly authorised officer of the Council if such modification or suspension complies with either Section 10.1 or Section 10.2 of the Act.
- 3.5 This Order shall come into operation on the 1st day of October 2019 and may be cited as the "Kirklees Council (Traffic Regulation) (No. 11) Order 2018".
