(TRAFFIC REGULATION) (NO. 4) ORDER 2016

Smithy Lane Moldgreen

Princess Street Huddersfield

Back Henrietta Street Batley

The Council of the Borough of Kirklees ("the Council") in exercise of their powers under Sections 1, 2, and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order which relates to a road at Smithy Lane, Moldgreen, Princess Street, Huddersfield and Back Henrietta Street, Batley in the Kirklees District:-

PART I

1. Interpretation

1.1. Save where the context requires, any reference in this Order to a numbered Article is a reference to the numbered Article bearing that number in this Order.

PART II

2. One-way traffic flow

- 2.1. Save as provided in Article 2.2 no person shall, except upon the direction or with the permission of a police constable in uniform or of a traffic warden, cause or permit any vehicle to proceed in that length of road specified in Column 1 of the Schedule to this Order in a direction other than that specified in relation to such length of road in Column 2 of that Schedule.
- 2.2 Nothing in Article 2.1 shall apply to any mechanical road cleansing vehicle when being used for that purpose.

PART III

3. Revocations

3.1 The orders referred to in Column 1 of the Second Schedule are hereby revoked to the extent shown in Column 2 of that Schedule.

PART IV

- 4. General
- 4.1. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any Regulations

- made or having effect as if made under the Act or by or under any other enactment.
- 4.2. Any reference in this Order to a Statute or Statutory Instrument shall include reference to any re-enactment or replacement thereof.
- 4.3. This Order shall come into operation on the 13th day of April 2018 and may be cited as the "Kirklees Council (Traffic Regulation) (No.4) Order 2016".

SCHEDULE 1

Smithy Lane, Moldgreen	From its junction with Gelder Terrace in a North Westerly direction to its junction with Wakefield Road, for a distance of 34 metres.
Back Henrietta Street, Batley	From its junction with Churchfield Street in a South Westerly direction to its junction with Upper Commercial Street, for a distance of 72 metres.

Princess Street, Huddersfield	Huddersfield C.B.C (TR) Order 1946. From its junction with Buxton Road (now New Street) to Corporation Street.
Back Henrietta Street, Batley	KMC (TR) (No16) Order 1993. From its junction with Upper Commercial Street in a North Easterly direction to its junction with Churchfield Street, for a distance of 72 metres.
John Street (now Buxton Way), Huddersfield	Huddersfield C.B.C (TR) Order 1946. From its junction with Buxton Road (now New Street) to Albion Street.
