

ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(CRAGG STREET AND FOTHERGILL STREET, COLNE, PENDLE BOROUGH)
(AMENDMENT TO PERMIT PARKING PROVISIONS) ORDER 2017

The County Council of Lancashire, in exercise of its powers under Sections 1, 2, 4, 45 and 46 and Part IV of Schedule 9 of the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Amendment

The "Lancashire County Council (Various Roads, Pendle Borough Area) (Revocation And Introduction Of Parking Places) Order 2015" ("the 2015 Order") is hereby amended as set out below:

a) Schedule 2 to the 2015 Order is amended to insert the table below:

Zone	Name of Street	Eligible Properties
Zone C16	Cragg Street	2-20 evens
	Fothergill Street	2-32 evens

b) Schedule 3 to the 2015 Order is amended to insert items (51) and (52) as set out below:

(51)	C16	Cragg Street, Colne	the south side	from a point 10 metres east of the centreline of Lord Street to a point 55 metres east of the centreline of Lord Street creating an echelon parking place.
(52)	C16	Fothergill Street, Colne	the east side	from a point 5 metres south of the centreline of North Valley Road to a point 5 metres north of the centreline of Cragg Street creating an echelon parking place."

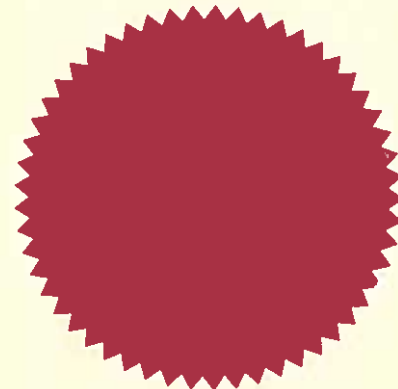
2. Commencement of Order

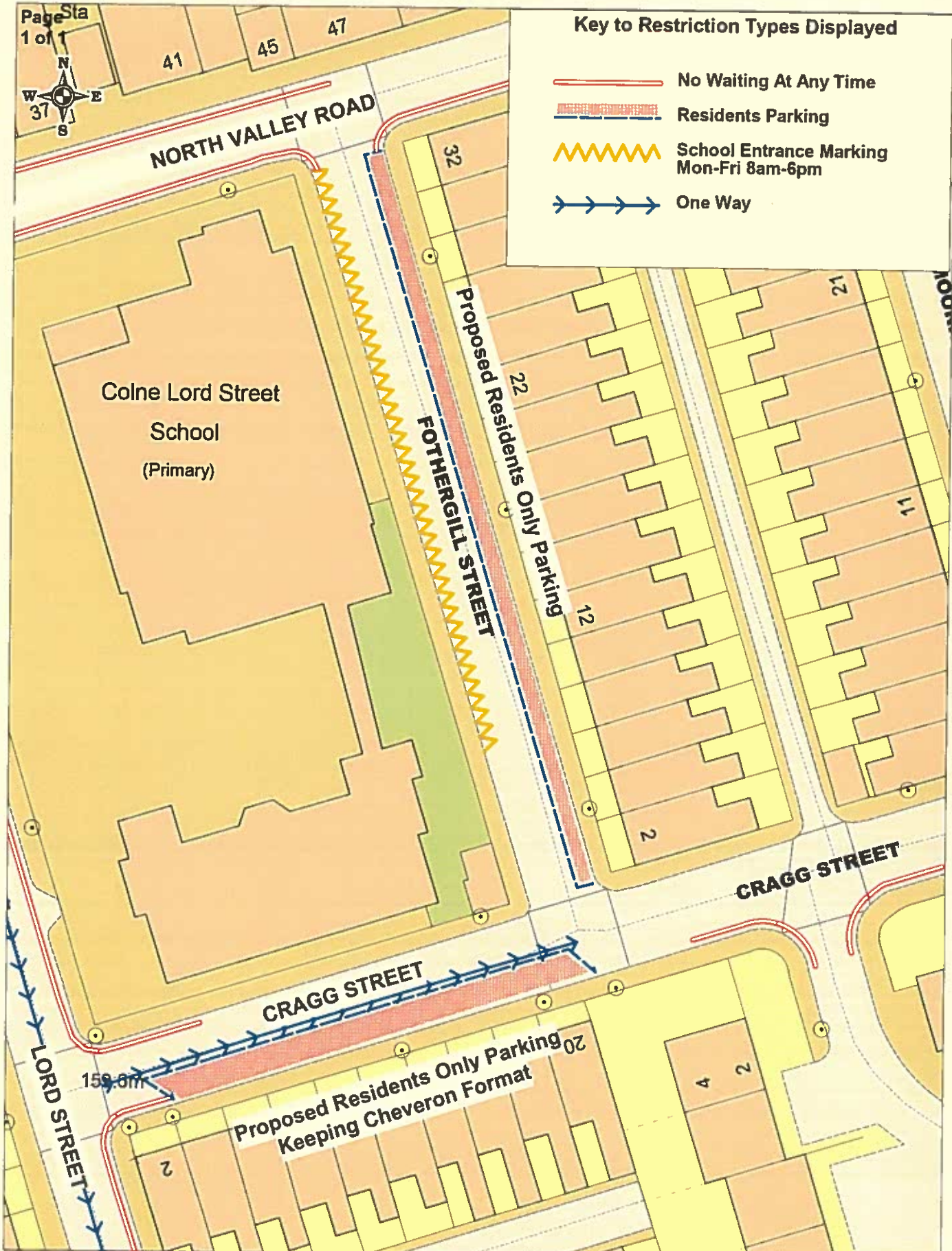
