

ROAD TRAFFIC REGULATION ACT 1984
LANCASHIRE COUNTY COUNCIL
(CHURCH STREET AND MARKET STREET, POULTON-LE-FYLDE, WYRE BOROUGH)
(PROHIBITION OF DRIVING EXCEPT PERMIT HOLDERS AND GOODS VEHICLE LOADING)
ORDER 2022

The County Council of Lancashire ("the Council") in exercise of its powers under Sections 1, 2 and 4 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. Definitions and Interpretation

For all the purposes of this Order the terms described in this Article shall have the meanings specified:

- a) **"Goods Vehicle"** has the same meaning as in section 192 (1) of the Road Traffic Act 1988;
- b) **"Loading"** and **"Unloading"** means the continuous transference from (or to) a Vehicle to (or from) premises adjacent to where the Vehicle is parked of heavy or unmanageable goods that are not designed to be carried by hand other than over a very short distance;
- c) **"Pedal Cycle"** means a unicycle, bicycle, tricycle, or cycle having four or more wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purposes of the 1984 Act;
- d) **"Vehicle"** means a motor vehicle, a passenger vehicle, a dual-purpose vehicle, a goods vehicle, a motorcycle or an invalid carriage or any other vehicle of any description whether drawn or propelled along a road by animal or mechanical power.

2. Revocation

"The Borough of Wyre (Market Place, Poulton-le-Fylde) (Revocation) (Pedestrian Area) Order 1986" is hereby revoked in full.

3. Prohibition of Driving Except Permit Holders At Any Time and Goods Vehicle Loading Between 4pm and Midnight and Midnight and 10am

Save as is hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle, at any time, to proceed in the land edged blue on the plan forming part of this Order generally described in the Schedule to this Order, unless that Vehicle is the holder of a valid Parking Permit, or is a Goods Vehicle and is engaged in the Loading and Unloading of goods between the hours of 4pm and midnight and midnight and 10am.

4. Exemptions

Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to travel along any part of the lengths of road referred to therein for so long as may be necessary to enable:

- a) the vehicle to be used for fire brigade, ambulance or police purposes in pursuance of statutory powers or duties;

- b) the vehicle to be used for the purposes of a local authority in pursuance of statutory powers or duties if it cannot conveniently be used for such purpose in any other road;
- c) the vehicle, if it cannot conveniently be used for such purpose in any other road to be used in connection with any of the following:-
 - i) building, industrial or demolition operations;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of the said lengths of roads;
 - iv) the laying, erection, alteration or repair in or in land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus or the exercise of any other statutory power or duty for the maintenance and supply of gas, water or electricity or of any telecommunications system as defined in Section 4 of the Telecommunications Act 1984.
- d) the vehicle being a security vehicle for the transfer of cash and/or securities to be used for the purpose of making deliveries to or collections from banking and building society premises having access from or fronting the lengths of road in this Order.

5. Miscellaneous

The prohibitions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made, or having effect as if made, under the Act or by or under any other enactment.

6. Commencement of Order

This Order shall come into force on the 05th day of September 2022 and may be cited as the "Lancashire County Council (Church Street And Market Street, Poulton-Le-Fylde, Wyre Borough) (Prohibition Of Driving Except Permit Holders And Goods Vehicle Loading) Order 2022"

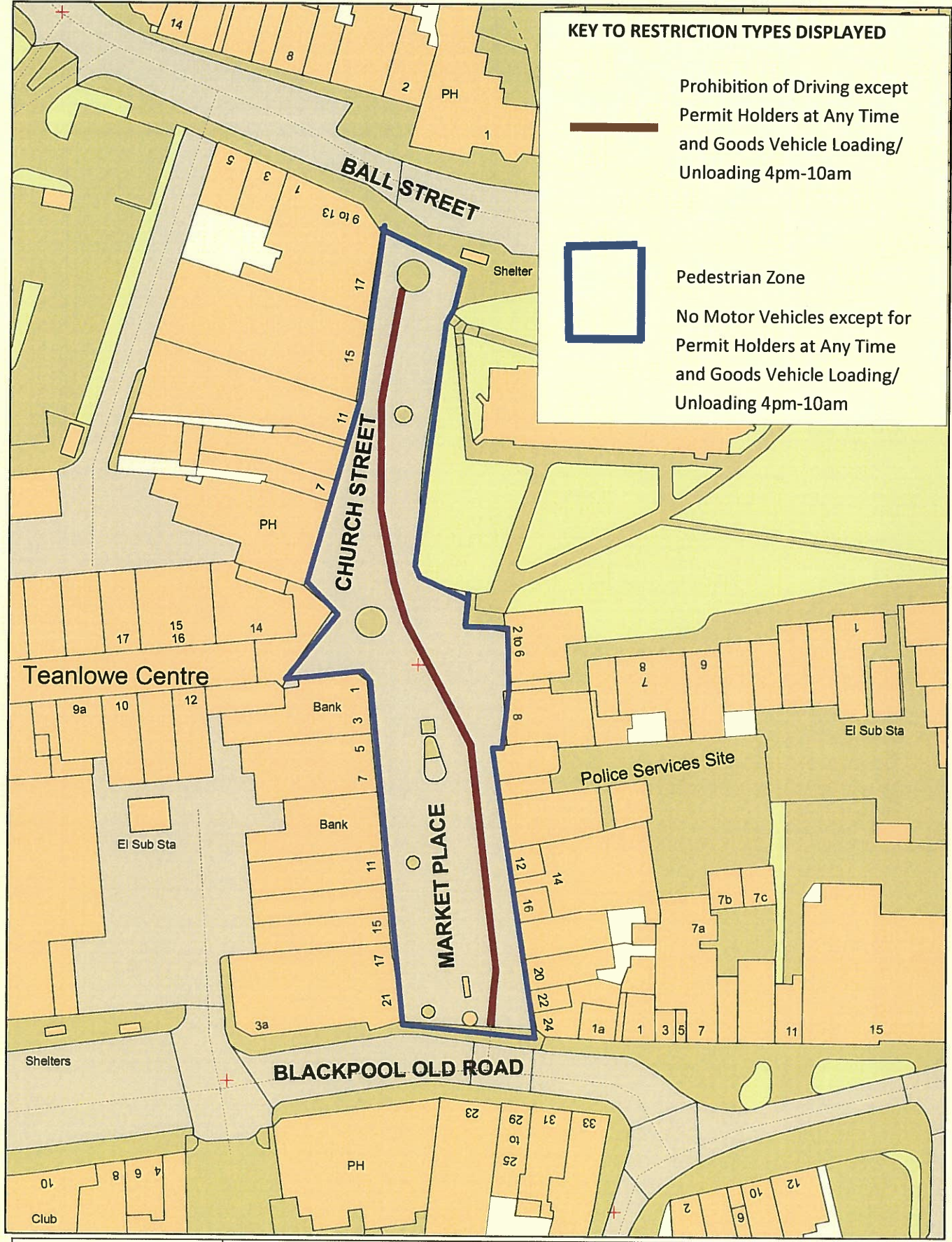
