

ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL

(VARIOUS ROADS, PENDLE BOROUGH) (REVOCATION AND VARIOUS PARKING RESTRICTIONS) (AMENDMENT) ORDER 2013

The County Council of Lancashire ("the Council") in exercise of its powers under Sections 1, 2 and 4 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. Definitions and Interpretation

For all the purposes of this Order the terms described in this Article shall have the meanings specified:

- a) **"Disabled Person's Badge"** means a badge which was –
 - i) issued, or has effect as if issued, to a disabled person or an institution under The Disabled Persons (Badges for Motor Vehicles) (England) Regulations or under regulations having effect in Scotland or Wales under Section 21 of the Chronically Sick and Disabled Persons Act 1970; and
 - ii) has not ceased to be in force.
- b) **"Disabled Person's Vehicle"** means a Vehicle displaying a Disabled Person's Badge in the circumstances prescribed in Regulations 13, 14, 15 or 16 of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.
- c) **"Parking Disc"** means a device which -
 - i) is 125 millimetres square and coloured blue, if issued on or after 1st April 2000, or orange if issued before that date;
 - ii) has been issued by a local authority and has not ceased to be valid; and
 - iii) is capable of showing the quarter hour period during which a period of waiting has begun.
- d) A Vehicle displays a Disabled Person's Badge in the **"Relevant Position"** if -
 - i) the badge is exhibited on the dashboard or fascia of the Vehicle, or
 - ii) where the Vehicle is not fitted with a dashboard or fascia the badge is exhibited in a conspicuous position on the Vehicle, so that the front of the badge is clearly legible from the outside of the Vehicle.
- e) A Vehicle displays a Parking Disc in the **"Relevant Position"** if -
 - i) the disc is exhibited on the dashboard or fascia of the Vehicle; or
 - ii) where the Vehicle does not have a dashboard or fascia, the disc is

exhibited in a conspicuous position on the Vehicle, so that when marked to show the quarter hour period during which a period of waiting began that period is clearly legible from the outside of the Vehicle.

- f) **"Vehicle"** means a motor Vehicle, a passenger Vehicle, a dual-purpose Vehicle, a goods Vehicle, a motorcycle or an invalid carriage or any other Vehicle of any description whether drawn or propelled along a road by animal or mechanical power;
- g) **"Civil Enforcement Officer"** means a person authorised by or on behalf of Lancashire County Council in accordance with Section 76 of the Traffic Management Act 2004;
- h) **"Parking Place"** means any area of the highway specified in articles 3 or 5f), 5g), 5h), 5i) and 5j).
- i) **"Centre Line"** means the centre line of a highway as shown on Ordnance Survey graphical information systems at the time that the Order was prepared.

2. Revocation

Those parts of the Orders as set out in Schedule 1 to this Order, are hereby revoked.

3. Disabled Parking Place

Save as is hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait, at any time, on any day, in the lengths of road as set out in schedule 2.01 to this Order, unless that Vehicle is a Disabled Person's Vehicle displaying a Disabled Persons Badge in the Relevant Position.

4. Prohibition of Waiting

Save as is hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait at any time, on any day, in the lengths of road set out in Schedule 10.01 to this Order.

5. Restriction of Waiting

- a) Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait on any day, between 07:00 and 19:00, in the lengths of road set out in schedule 11.006 to this Order.
- b) Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait on any day, between 08:00 and 18:00 in the lengths of road set out in schedule 11.007 to this Order.
- c) Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait between 08:00 and 18:00, from Monday to Friday inclusively in the lengths of road set out in schedule 11.040 to this Order.
- d) Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait between 07:00 and 19:00, from Monday to Saturday inclusively in the length of road set out in schedule 11.071 to this Order.

- e) Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait between 08:00 and 18:00, from Monday to Saturday inclusively in the length of road set out in schedule 11.075 to this Order.
- f) Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait for a period exceeding 1 hour, no return within 1 hour, between 08:00 and 18:00 from Monday to Saturday inclusively, in the lengths of road as set out in schedule 12.066 to this order.
- g) Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait for a period exceeding 1 hour, no return within 2 hours, between 07:00 and 19:00 from Monday to Saturday inclusively, in the lengths of road set out in schedule 12.083 to this order.
- h) Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait for a period exceeding 1 hour, no return within 2 hours, between 08:00 and 18:00 from Monday to Saturday inclusively, in the lengths of road set out in schedule 12.084 to this order.
- i) Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait for a period exceeding 1 hour, no return within 2 hours, between 08:30 and 18:00 from Monday to Saturday inclusively, in the lengths of road set out in schedule 12.086 to this order.
- j) Save as in hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any Vehicle to wait for a period exceeding 2 hours, no return within 2 hours, between 08:00 and 18:00 from Monday to Saturday inclusively, in the length of road set out in schedule 12.105 to this order.

6. Prohibition of Stopping on School Keep Clear Markings

Save as is hereinafter provided, no person shall, except upon the direction or with the permission of a police constable in uniform, or a Civil Enforcement Officer, cause or permit any vehicle, to stop or wait from 08:00 until 18:00 from Monday to Friday (inclusively), in the lengths of road set out in Schedule 15.07 to this order.

7. General Exemptions

Nothing in Articles 3, 4 or 5 to this Order shall render it unlawful to cause or permit any Vehicle to wait in the lengths of road referred to therein for so long as may be necessary to enable:-

- a) a person to board or alight from the Vehicle;
- b) goods to be loaded on to or unloaded from the Vehicle;
- c) the Vehicle, if it cannot conveniently be used for such purpose in any other road to be used in connection with any of the following:-
 - i) building, industrial or demolition operations;
 - ii) the removal of any obstruction to traffic;

- iii) the maintenance, improvement or reconstruction of the said lengths of roads;
- iv) the laying, erection, alteration or repair in or in land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus or the exercise of any other statutory power or duty for the maintenance and supply of gas, water or electricity or of any telecommunications system as defined in Section 4 of the Telecommunications Act 1984;
- d) the Vehicle to be used for the purposes of a local authority in pursuance of statutory powers or duties if it cannot conveniently be used for such purpose in any other road;
- e) A Royal Mail liveried Vehicle to be used for delivering or collecting postal packets in accordance with the statutory provisions as defined in the Postal Services Act 2000;
- f) The Vehicle to be used for fire brigade, ambulance or police purposes in pursuance of statutory powers or duties.
- g) The Vehicle to wait at or near to any premises situated on or adjacent to said length of road for so long as such waiting by the Vehicle is reasonably necessary in connection with any wedding or funeral.

8. Exemptions to Article 6

Nothing in Article 6 to this Order shall render it unlawful to cause or permit any Vehicle to wait in the lengths of road referred to therein for so long as may be necessary to enable:-

- a) the Vehicle, if it cannot conveniently be used for such purpose in any other road to be used in connection with any of the following:-
 - v) building, industrial or demolition operations;
 - vi) the removal of any obstruction to traffic;
 - vii) the maintenance, improvement or reconstruction of the said lengths of roads;
 - viii) the laying, erection, alteration or repair in or in land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus or the exercise of any other statutory power or duty for the maintenance and supply of gas, water or electricity or of any telecommunications system as defined in Section 4 of the Telecommunications Act 1984;
- b) the Vehicle to be used for the purposes of a local authority in pursuance of statutory powers or duties if it cannot conveniently be used for such purpose in any other road;
- c) The Vehicle to be used for fire brigade, ambulance or police purposes in pursuance of statutory powers or duties.

9. Exemptions for Disabled Person's Vehicles

- a. Nothing in Articles 5f), 5g), 5h), 5i) and 5j) of this Order shall render it unlawful to cause or permit any Vehicle to wait in the lengths of roads referred to therein if the Vehicle is a Disabled Person's Vehicle which displays in the Relevant Position both a Disabled Person's Badge and a Parking Disc marked to show the quarter hour period during which the period of waiting began.
- b. Nothing in Articles 4, 5a), 5b), 5c), 5d) and 5e) of this Order shall render it unlawful to cause or permit any Vehicle to wait in the length of road referred to therein for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same Vehicle in the same length of road on the same day) if the Vehicle is a Disabled Person's Vehicle which displays in the Relevant Position both a Disabled Person's Badge and a Parking Disc marked to show the quarter hour period during which the period of waiting began.

10. Additional Exemptions

Nothing in Articles 3, 4, 5 or 6 of this Order shall render it unlawful to cause or permit any Vehicle to wait, in the lengths of road referred to therein When the person in control of the Vehicle

- i. is required by law to stop;
- ii. is obliged to stop in order to avoid an accident; or
- iii. is prevented from proceeding along the road due to circumstances beyond his/her control

11. Manner of standing in a Parking Place

- a) The driver of a motor Vehicle using a Parking Place shall stop the engine as soon as the Vehicle is in a position in the Parking Place and shall not start the engine except when about to change the position of the Vehicle in or, or depart from, the Parking Place.
- b) Every Vehicle left in a Parking Place in accordance with the foregoing provisions of this Order shall be left so that every part of the Vehicle is within the limits of the Parking Place.
- c) A driver of a Vehicle shall not use a Parking Place so as unreasonably to prevent access to any premises adjoining a road or the use of a road by other persons or so as to be a nuisance.

12. Alteration of position of a Vehicle in a Parking Place

Where any Vehicle is left standing in a Parking Place in contravention of the provisions of Article 11 of this Order, a police constable in uniform or a Civil Enforcement Officer may alter or cause to be altered the position of the Vehicle in order that its position shall comply with those provisions.

13. Removal of a Vehicle from a Parking Place

Where a police constable in uniform or a Civil Enforcement Officer is of the opinion that any of the provisions contained in Article 11 of this Order have been contravened or not complied with in respect of a Vehicle left in a Parking Place, he/she may remove or cause to be removed the Vehicle from the said Parking Place, and where it is so removed, shall provide for the safe custody of the said Vehicle.

14. Movement of a Vehicle in a Parking Place in an Emergency

- a) A police constable in uniform or a Civil Enforcement Officer may in case of emergency move or cause to be moved any Vehicle left in a Parking Place to any place he thinks fit and shall provide for the safe custody of the Vehicle.

- b) A person causing or permitting a Vehicle to wait in a Parking Place by virtue of the provisions of articles 7 and 10 of this Order shall take all such steps as are necessary to ensure that in the case of a Parking Place it shall stand in accordance with Article 11 so that every part of the Vehicle is within the limits of the Parking Place.

15. Power to suspend use of Parking Places

- a) The Council's Duly Authorised Officer may suspend the use of a Parking Place or any part thereof whenever he/she considers such suspensions reasonably necessary and make such charge for the administration of this service, as may from time to time be determined by the Council.
- b) A police constable in uniform may suspend for not longer than 7 days the use of a Parking Place or any part thereof whenever he/she considers such suspension reasonably necessary for the purpose of mitigating congestion or obstruction of traffic or a danger to or from traffic in consequence of extraordinary circumstances.
- c) Any persons suspending the use of a Parking Place or any part thereof in accordance with the provisions of paragraph a) or b) of this Article shall thereupon place or cause to be placed in or adjacent to any part of that Parking Place the use of which is suspended, an authorised Traffic Sign or cone indicating that waiting by Vehicles is prohibited.
- d) No person shall cause or permit a Vehicle to be left in any part of a Parking Place during such period when an authorised Traffic Sign or cone is placed in or adjacent to that part of the Parking Place pursuant to paragraph c) of this Article provided that this paragraph shall not apply to a Vehicle:
 - i) being used by the respective Fire or Police Authority or Ambulance Health Trust to deal with an emergency; or
 - ii) being used for any purpose specified in Article 10; or
 - iii) left in such Parking Place with the permission of the person suspending the use of the Parking Place.

16. Restriction of use of a Vehicle in a Parking Place

While any Vehicle is in the lengths of road specified in articles 3, 5f), 5g), 5h), 5i) and 5j), no person shall use the said Vehicle in connection with the sale of any article to any person in or near the Parking Place or in connection with the selling of or offering for sale of his/her skills or services.

17. Miscellaneous

The prohibitions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made, or having effect as if made, under the Act or by or under any other enactment.

18. Effect of Contravention

Failure by a person to comply with any prohibition or restriction contained within this order or any subsequent orders shall constitute a contravention of the same and shall result in the issue by Lancashire County Council and/or its Agents of a Penalty Charge Notice which shall be payable by such persons in accordance with the legislation.

19. Commencement of Order

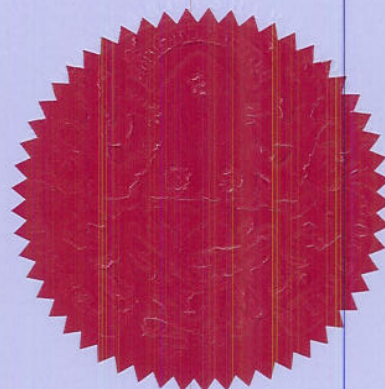

- (i) Market Square, the north-east side, north-east side of the south-western carriageway from a point 53 metres south-east of its junction with Every Street for a distance of 8 metres in a south-easterly direction
- (ii) Market Square, the south-west side, (south-westerly side of the north-eastern carriageway) from a point 58 metres south-west of its junction with Every Street for a distance of 8 metres in a south-easterly direction

No Waiting At Any Time

- (i) Albert Road, the north side, from its junction with Parsonage Street to its junction with Princess Street
- (ii) Broken Banks, the north side, from a point 5 metres from its eastern end for 6 metres in a westerly direction
- (vi) Church Street, the south side, from a point 36.5 metres or thereabouts west of its junction with Walton Street to its junction with Colne Lane except from a point 12 metres west of the centre line of Colne Lane for a distance of 27 metres in a westerly direction
- (x) Colne Road, the north-west side, from a point adjacent to No. 218 Colne Road for a distance of 59 metres or thereabouts in a north-easterly direction
- (xiv) Cross Street, the east side, from its junction with Market Street for a distance of 23 metres in a northerly direction
- (xviii) Dockray Street, the east side, from a point 15 metres south of the centre line of Dockray Court for a distance of 22 metres in a southerly direction
- (xxii) Dockray Street, the east side, from the centre line of Market Street for a distance of 5 metres in a northerly direction
- (xxvi) Halifax Road, the north side, from its junction with Colne Road for 15 metres in an easterly direction
- (xxx) Jude Street, both sides, for 15 metres in a northerly direction from the southern end of the street and to include the end of the cul-de-sac (10 metres in width)

(xxxiv) Manchester Road, both sides, from its junction with Hargreaves Street to the Borough Boundary of Brierfield

(xxxviii) Market Street, the north-west side, from the centre line of Brook Street for a distance of 7 metres in a north-easterly direction

(xlii) Pendle Street, the north side, from a point 10 metres from its junction with Cross Street for 3 metres in an easterly direction

(xlvi) Russell Street, the north side, from its junction with Back Scotland Road for a distance of 20 metres in a westerly direction

(l) Russell Street, the south side, from its junction with Back Scotland Road to its junction with Jude Street

(liv) Scotland Road, both sides, from its junction with Russell Street to a point 9 metres south of its junction with Pendle Street

(lviii) Scotland Road, the west side, from its junction with Pendle Street for a distance of 9 metres in a southerly direction

(lxii) Walton Street, the east side, from its junction with Church Street to its junction with Cloth Hall Street

No Waiting 8am-6pm

(i) Halifax Road, the north side, from a point 15 metres east of Burnley Road/Colne Road, A 56 to Arthur Street

(ii) Halifax Road, the south side, from Craven Street to Walter Street

No Waiting Mon-Fri 8am-6pm

(i) Bent Lane, the south-west side, from a point 10 metres from its junction with Keighley Road for 65 metres in a north-westerly direction

(ii) Rutland Street, the west side, from its junction with Gordon Street for a distance of 90 metres in a southerly direction

(iii) Stanley Street, both sides, from its junction with Halifax Road for 10 metres in a northerly direction

- (i) Dockray Street, the east side, from its junction with Water Street for a distance of 14 metres in a southerly direction
