

ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL (HOUGH LANE, LEYLAND, SOUTH RIBBLE BOROUGH) (REVOCATION OF LIMITED WAITING, TAXI RANK AND LIMITED WAITING) ORDER 2012

The County Council of Lancashire ("the Council") in exercise of its powers under Sections 1, 2 and 4 of and Part 1V of Schedule 9 to the **Road Traffic Regulation Act 1984**, as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. Definitions and Interpretation

For all the purposes of this Order the terms described in this Article shall have the meanings specified:

- a) **"disabled person's vehicle"** means a vehicle displaying a disabled person's badge in the circumstances prescribed in Regulations 13, 14, 15 or 16 of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.
- b) **"Disabled Person's Badge"** means a badge which was -
 - i) issued, or has effect as if issued, to a disabled person or an institution under The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 or under regulations having effect in Scotland or Wales under Section 21 of the Chronically Sick and Disabled Persons Act 1970; and
 - ii) has not ceased to be in force.
- c) **"parking disc"** means a device which -
 - i) is 125 millimetres square and coloured blue, if issued on or after 1st April, 2000 or orange if issued before that date;
 - ii) has been issued by a local authority and has not ceased to be valid; and
 - iii) is capable of showing the quarter hour period during which a period of waiting has begun.
- d) **A vehicle displays a disabled person's badge in the relevant position if -**
 - i) the badge is exhibited on the dashboard or fascia of the vehicle, or
 - ii) where the vehicle is not fitted with a dashboard or fascia the badge is exhibited in a conspicuous position on the vehicle, so that the front of the badge is clearly legible from the outside of the vehicle.
- e) **A vehicle displays a parking disc in the relevant position if -**
 - i) the disc is exhibited on the dashboard or fascia of the vehicle; or
 - ii) where the vehicle does not have a dashboard or fascia, the disc is exhibited in a conspicuous position on the vehicle so that when marked to show the quarter hour period during which a period of waiting began that period is clearly legible from the outside of the vehicle.

- f) **“civil enforcement officer”** means a person authorised by or on behalf of Lancashire County Council in accordance with Section 76 of the Traffic Management Act 2004;
- g) **“authorised taxi rank”** means any area of carriageway which is comprised within and indicated by a road marking, complying with diagram 1028.2 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002.
- h) **“Licensed Taxi”** means a vehicle licensed under Section 37 of the Town Police Clauses Act 1847
- i) **“vehicle”** means a motor vehicle, a passenger vehicle, a dual-purpose vehicle, a goods vehicle, a motorcycle or an invalid carriage or any other vehicle of any description whether drawn or propelled along a road by animal or mechanical power;

2. **Revocation**

Revoke that part of the “Lancashire County Council (South Ribble Borough Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009” as specified in **Schedule 1** to this Order is hereby revoked.

3. **Restriction of Waiting**

Save as is hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, cause or permit any vehicle to wait for a period exceeding one hour, no return within one hour, from Monday to Saturday inclusively, from 0700 hours until 1800 hours each day, along the length of Hough Lane, Leyland as specified in **Schedule 2** to this Order.

4. **Authorised Taxi Rank**

Save as is hereinafter provided no person shall, except upon the direction or with the permission of a police constable in uniform, or a civil enforcement officer, cause or permit any vehicle other than a licensed Taxi to wait, at any time on any day, along the length of Hough Lane, Leyland, specified in **Schedule 3** to this Order.

5. **General Exceptions**

Nothing in Article 3 or 4 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road referred to therein for so long as may be necessary to enable:-

- a) for so long as it may be necessary to enable a person to board or alight the vehicle;
- b) if it cannot conveniently be used for such purpose in any other road to be used in connection with any of the following:-
 - i) building, industrial or demolition operations;
 - ii) the removal of any obstruction to traffic;
 - iii) the maintenance, improvement or reconstruction of the said lengths of road;
 - iv) the laying, erection, alteration or repair in or near land adjacent to the said lengths of road of any sewer or of any main, pipe or apparatus or the exercise of any other

statutory power or duty for the maintenance and supply of gas, water or electricity or of any telecommunications system as defined in Section 4 of the Telecommunications Act 1984;

- c) if the vehicle is to be used for the purposes of a local authority in pursuance of statutory powers or duties if it cannot conveniently be used for such purpose in any other road;
- d) if the vehicle is a Royal Mail liveried vehicle engaged in the collection and/or delivery of letters in accordance with the statutory provisions as defined in the Postal Services Act 2000;
- e) if the vehicle is to be used for fire brigade, ambulance or police purposes in pursuance of statutory powers or duties;
- f) if the vehicle is to wait at or near to any premises situated on or adjacent to the said lengths of road for so long as such waiting by the vehicle is reasonably necessary in connection with any wedding or funeral.

6. Exception to Article 3

Nothing in Article 3 of this Order shall render it unlawful to cause or permit goods to be loaded on to or unloaded from the vehicle.

7. Exemption for disabled person's vehicle

Nothing in Article 3 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of roads referred to therein if the vehicle is a disabled person's vehicle which displays in the relevant position both a disabled person's badge and a parking disc marked to show the quarter hour period during which the period of waiting began.

8. Miscellaneous

The restriction imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made, or having effect as if made, under the Act or by or under any other enactment.

9. Commencement of Order

This Order shall come into force on the 13th February 2012 and may be cited as the "Lancashire County Council (Hough Lane, Leyland, South Ribble Borough) (Revocation Of Limited Waiting, Taxi Rank And Limited Waiting) Order 2012".

Schedule 1

Revoke that part of the "Lancashire County Council (South Ribble Borough Area) (On Street Parking Places, Prohibition and Restriction of Waiting) Consolidation Order 2009" Schedule 12.064 Item (2)(i), insofar as it relates to Hough Lane, Leyland, the south side, from a point 9 metres east of the centre line of Thurston Road to a point 39 metres west of the centre line of Alice Avenue.

Schedule 2

Introduce No Waiting, from 07:00 hours – 18:00 hours on Monday – Saturday inclusively on Hough Lane, Leyland, south side, from a point 9 metres east of the centre line of Thurston Road to a point 34.5 metres east of the centre line of Meadow Street.

Schedule 3

Introduce a Taxi Stand on Hough Lane, Leyland, north-east side, from a point 34.5 metres east of the centre line of Meadow Street for a distance of 17.5 metres in a north-easterly direction.

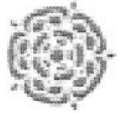
