

ROAD TRAFFIC REGULATION ACT 1984

LANCASHIRE COUNTY COUNCIL (VARIOUS ROADS, EVERY DISTRICT, LANCASHIRE) (AMENDMENT OF 2009 CONSOLIDATION ORDERS) ORDER 2014

The County Council of Lancashire, in exercise of its powers under Sections 1, 2 and 4 of and Part IV of Schedule 9 of the **Road Traffic Regulation Act 1984**, as amended, ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order: -

1. Amendment

a) The Orders as set out in Schedule 1 to this Order are hereby amended to remove articles 1.2.2, 1.2.3, 1.2.5, 1.2.12, 1.2.15 and 1.2.27 therein, and replace them with the following:

1.2.2 - "Ambulance Parking Place" means any area of the carriageway which is comprised within and indicated by a road marking approved by the DfT

1.2.3 "Authorised Taxi Rank/Stand" means any area of the carriageway which is comprised within and indicated by a road marking approved by the DfT.

1.2.5 "Bus stop area" means any area of the carriageway intended for the waiting of buses, which is comprised within and indicated by a road marking approved by the DfT.

1.2.12 "Disabled Persons Parking Place" means any area of highway described in Schedule 2 to this order within which comprises of bay/bays indicated by a road marking and accompanied by a sign both of which are approved by the DfT.

1.2.15 "Doctors Parking Place" means any area of highway described in Schedule 4 to this order which is comprised within and indicated by a road marking approved by the DfT.

1.2.27 "Loading Bay" means any area of the highway which is comprised within and indicated and indicated by a road marking approved by the DfT.

b) Article 4.1 of the Orders set out in Schedule 1 to this Order are hereby amended to read as follows

"4.1 Save as provided in Article 17.1 of this Order, no person shall except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer cause or permit any vehicle to wait in a Disabled Person's Parking Place at any time, or during the Permitted Hours unless he is the holder of a valid Disabled Parking Permit and he displays such badge on that vehicle."

c) Article 14 of the Orders set out in Schedule 1 to this Order are hereby amended to read as follows

"14. Loading Bay

No person shall leave any vehicle at a Loading Bay at any time or during the permitted hours if indicated:-

14.1.1 unless such vehicle is left at such Loading Bay for the purpose of loading and/or unloading goods (which includes loading bays specified for Goods Vehicles) and

14.1.2 unless the vehicle is left at the Loading Bay for a period of time not exceeding any as may be specified in Schedule 8."

d) The "Lancashire County Council (Manchester Road and Leads Road, Nelson, Pendle Borough) (Revocation, Part Revocation, Disabled Parking Places and Restriction of Waiting) Order 2011" is hereby amended to replace references to "disabled parking place" with "Disabled Persons Parking Place".

e) The "Lancashire County Council (Manchester Road and Leads Road, Nelson, Pendle Borough) (Revocation, Part Revocation, Disabled Parking Places and Restriction of Waiting) Order 2011" is hereby amended to replace the definition of "disabled parking place" contained in article 1a) of that Order, with the definition set out in schedule 2 to this Order.

2. Commencement of Order

This Order may be cited as the "Lancashire County Council (Various Roads, Every District, Lancashire) (Amendment Of 2009 Consolidation Orders) Order 2014" and shall come into force on the 1st day of September 2014.
