

ROAD TRAFFIC REGULATION ACT 1984 – SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of parking restrictions on roads for which Lancashire County Council is the traffic authority, hereby:-

- authorises the erection at appropriate sites on the said roads of a traffic sign conforming as to size, colour and character with that shown as Sign A in the attached set of drawing numbered GT50/064/0031-1 (hereinafter referred to as "the authorised sign A"), save that the code identifier patch may be varied or omitted; and
- authorises the erection at appropriate sites on the said roads of a traffic sign conforming as to size, colour and character with that shown as Sign B in the said set of drawing (hereinafter referred to as "the authorised sign B"), save that the code identifier patch may be varied or omitted; and
- directs that the signs to diagrams 660 and 661A in Schedule 2 to the 2002
 Regulations may be erected in sufficient numbers to give adequate information to road users of waiting restrictions in force on the said roads; and
- directs that it is a condition of this authorisation that the authorised signs A and B shall be erected only to indicate the effect of a corresponding Traffic Regulation Order; and



5. directs, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised signs A and B at or near the said sites shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect; and


The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised signs A and B in the same manner as they apply to the sign to diagram 663.3 in Schedule 2 to those Regulations.


