**(TRAFFIC REGULATION) (AMENDMENT) (NO 1) ORDER 2001**

The City Council of Lancaster (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the County Council of Lancashire in exercise of the powers of the said County Council under Section 1 and 2 (1) (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Schedule 9 (Part III) of the Act of 1984 hereby make the following Order:-

**PART A**

**GENERAL**

1. (1) This Order shall come into operation on the 1<sup>st</sup> March 2001 and may be cited as "The City Council of Lancaster (Lancaster City Centre) (Traffic Regulation) (Amendment) Order 2001.
- (2) The City Council of Lancaster (Lancaster City Centre) (Traffic Regulation) (Consolidation and Amendment) Order 2000, the Principal Order, is hereby amended to revoke those parts of Schedule 8 of the Principal Order specified in Schedule 1 of this Order.
- (3) The Principal Order is hereby amended to include in Schedule 8 of the Principal Order all references in Schedule 2 to this Order.
- (4) The Principal Order is hereby amended to include an additional Schedule, referred to as Schedule 12.
- (5) The Principal Order is hereby amended to include in Schedule 12 of the Principal Order all references in Schedule 3 to this Order.

(6) Article 7 and its heading in Part B of the Principal Order is hereby amended so as to read:

**"LIMITED WAITING**

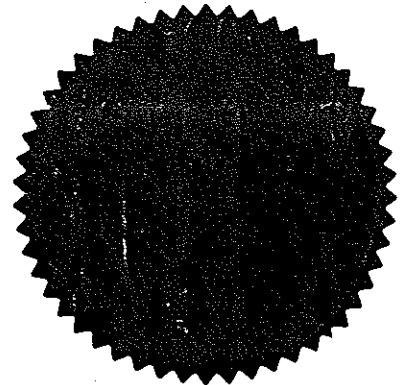
7. (1) Save as provided in Articles 23 and 24 of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to wait more than 2 hours, return prohibited within 4 hours between 8:00 a.m. and 6:00 p.m. Mondays to Saturdays inclusive, in any of the roads specified in Schedule 3 to the Order.

(2) Save as provided in Articles 23 and 24 of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to wait more than 30 minutes, return prohibited within 1 hour, in any of the roads specified in Schedule 12 to the Order."

The Prohibitions and Restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by a regulation made or having effect as if made under the Act or by or under any other enactment.

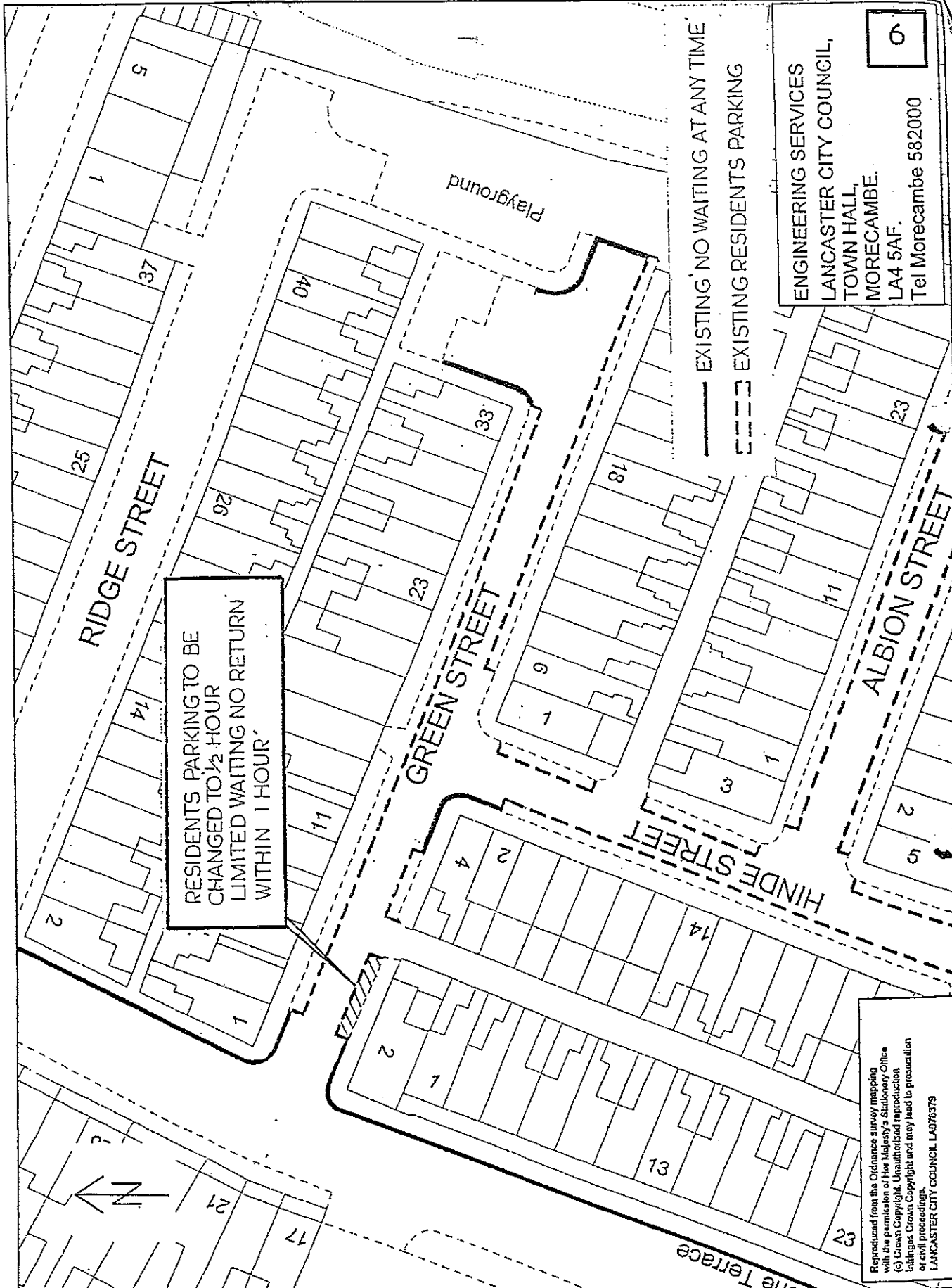
