THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006
(AMENDMENT) (HARTINGTON ROAD & APOLLO CLOSE AREA) (NO.142)
ORDER 2013

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment) (Hartington Road & Apollo Close Area) (No.142) Order 2013, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on Monday 4th November 2013.
2.
 - (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the Schedules relating to
Apollo Close
Atlas Close
Bakewell Street
Haddon Street
Morley Road
Pegasus Close
Vostock Close
Willow Court
 - (ii) In Schedule 1 to the Principal Order insert the Schedule hereto in appropriate alphabetical order
4. The Council hereby revoke all the restrictions in the Leicester (Consolidation) Traffic Regulation Order 1975("the 1975 Order") and its subsequent amendments in so far as they impose restrictions on the following roads. Restrictions imposed by the 1975 Order on other roads will remain in force

Hartington Road

5. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

SCHEDULE

APOLLO CLOSE

Inner Side

- Part 207 from its junction with Atlas Close to its north east extremity including the turning head

Outer Side

- Part 207 from its north-east extremity including the turning head to a point 58 metres south of its north-east extremity
- Part 207 from a point 2 metres north-east of the south-western boundary of number 19/23, Apollo Close to a point 9 metres north-west of a point in line with the back of footway in front of 19 to 57, Apollo Close
- Part 207 from a point 20 metres south of its junction with Atlas Close to its junction with Atlas Close including its junction with Maidstone Road

APOLLO COURT

Eastern Side

- Part 207 from its junction with Apollo Close to a point 5 metres south-east of a point in line with the back of footway in front of 19 to 57, Apollo Close

Western Side

- Part 207 from a point 3 metres south of a point in line with the north-eastern boundary of 2/12 Apollo Court to its junction with Apollo Close

ATLAS CLOSE

North Side

- Part 207 from a point 2 metres west of the western boundary of number 2 Atlas Close to its eastern extremity including the turning head but excluding the parking bays

South Side

- Part 207 from its eastern extremity to a point 3 metres west of its eastern extremity
- Part 207 on the eastern side of its junction with Apollo Close from a point 2 metres east of the western boundary of number 2 Atlas Close to its junction with Apollo Close
- Part 207 on the western side of its junction with Apollo Close from a point 12 metres north of a point in line with the north-eastern property boundary wall of 79, Maidstone Road to its junction with Apollo Close

BAKEWELL STREET

- Part 100 One Way Street from its junction with Berners Street to its junction with Hartington Road in that direction

East Side

- Part 207 from its junction with Hartington Road to a point 4 metres south of its junction with Hartington Road

West Side

- Part 207 from a point 4 metres south of its junction with Hartington Road to its junction with Hartington Road

HADDON STREET

- Part 100 One Way Street from its junction with Hartington Road to its junction with Berners Street in that direction

East Side

- Part 207 from its junction with Hartington Road to a point 3 metres south of its junction with Hartington Road

HARTINGTON ROAD

Part 100 One Way Street from its junction with Mere Road to its junction with Melbourne Road in that direction

North Side

Part 207 from its junction with Melbourne to a point 5 metres south-east of its junction with Florence Road

Part 207 from a point 3 metres north-west of a point opposite the west side of its junction with Chatsworth Street to a point 14 metres south-east of a point opposite the east side of its junction with Chatsworth Street

Part 302 from a point 38 metres north-west of its junction with Mere Road to a point 32 metres north-west of its junction with Mere Road

Part 207 from a point 8 metres north-west of its junction with Mere Road to its junction with Mere Road

South Side

Part 207 from its junction with Mere Road to a point 5 metres north-west of its junction with Mere Road

Part 207 from a point in line with the east side of its junction with Bakewell Street to a point 4 metres north-west of its junction with Bakewell Street

Part 207 from a point 2 metres south-east of its junction with Haddon Street to its junction with Haddon Street

Part 207 from a point 18 metres south-east of its junction with Melbourne Road to its junction with Melbourne Road

MORLEY ROAD

Part 100 One Way Street from its junction with Vulcan Road to its junction with St Saviour's Hill in that direction

North-west Side

Part 207 from its junction with Vulcan Road to a point 4 metres north-east of its junction with Vulcan Road

South-east Side

Part 207 from its junction with St Saviour's Hill to a point 9 metres south-west of its junction with St Saviour's Hill

Part 207 from a point 9 metres north-east of a point in line with the north-west side of its junction with Vulcan Road to its junction with Vulcan Road

PEGASUS CLOSE

Northern Side

Part 207 from 2 metres west of the south-west corner of number 6 Pegasus Close to 2 metres east of the south-east corner of number 16 Pegasus Close

Southern Side

Part 207 on the eastern side of its junction with Vostock Close from a point 9 metres west of a point in line with the western boundary of 1/9, Pegasus Close to its junction with Vostock Close

Part 207 on the western side of its junction with Vostock Close from a point 22 metres north of a point in line with the northern boundary of 2/6, Vostock Close to its junction with Vostock Close

VOSTOCK CLOSE

Inner Side

Part 207 from its junction with Pegasus Close to a point in line with the western property boundary of number 39 Vostock Close

Outer Side

Part 207 from a point in line with the western property boundary of number 39 Vostock Close to a point 15 metres south of a point in line with the southern property boundary of number 16 Vostock Close

Part 207 from a point 22 metres north of a point in line with the southern property boundary of number 16 Vostock Close to its junction with Maidstone Road including its junction with Pegasus Close

WILLOW COURT

Inner Side

Part 207 from its south-east extremity to its junction with Sparkenhoe Street

Outer Side

Part 207 from a point 21 metres north-east of the building line at its junction with Sparkenhoe Street to a point 28 metres north-west of its south-eastern extremity

Part 207 from a point 20 metres north-west of its south-eastern extremity to its south-eastern extremity including the turning head
