

LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (VULCAN ROAD AREA) (No. 296) ORDER 2020

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under sections 1, 2, 32, 35, 45, 46, 46A, 49, 51, 53 and 63A of the Road Traffic Regulation Act 1984 ("the 1984 Act") and of Part IV of Schedule 9 to the 1984 Act and of all other enabling powers including the Road Traffic Act 1991 as amended (whether generally or in relation to the area of the Council) ("the 1991 Act") and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the 1984 Act hereby make the following Order in Part:-

- This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Vulcan Road Area) (No.296) Order 2020 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into operation on the 21st day of September 2020.
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 of the Principle Order revoke existing schedules relating to Beaumont Road, Hart Road, Hartington Road, Maynard Road, Sherrard Road, St Saviours Road and Vulcan Road
 - (ii) In Schedule 1 to the Principal Order insert Schedule 1 hereto in the appropriate alphabetical order
 - (iii) In Section 3 of the Principal Order entitled Waiting Restrictions after existing Part 255 insert Schedule 2 hereto
- 4. The Council hereby revoke all the restriction in the Leicester (Consolidation) Traffic Regulation Order 1975 ("the 1975 Order") and its subsequent amendments in so far as they impose restrictions on the following roads:

Vulcan Road

5. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order
