## THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (WHARF STREET NORTH) (No. 316) ORDER 2022

Leicester City Council (the Council) in exercise of their powers under Section 1 and 2 of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

- This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) Wharf Street North) (No.316) Order 2022 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 30<sup>th</sup> January 2022
- 2. (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
  - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
  - (i) In Schedule 1 to the Principal Order revoke the existing schedules relating to

Wharf Street North

- (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order
- 4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

Part 301	from a point 31 metres south of a point opposite the south side of its junction with Manitoba Road to a point 25 metres south of a point opposite the south side of its junction with Manitoba Road
Part 224	from a point 25 metres south of a point opposite the south side of its junction with Manitoba Road to a point 10 metres south of a point opposite the south side of its junction with Manitoba Road

Part 200 From a point 10 metres south of a point opposite the south side of its junction with Manitoba Road to a point 6 metres north of a point opposite the south side of its junction with Manitoba Road Part 224 the layby from a point 6 metres north of a point opposite the north side of its junction with Manitoba Road to a point 16 metres south of its junction with Upper George Street Part 207 from a point 16 metres south of its junction with Upper George Street to a point 10 metres north of its junction with Upper George Street Part 215 from a point 10 metres north of its junction with Upper George Street to a point 22 metres north of its junction with Upper George Street Part 207 from a point 22 metres north of its junction with Upper George Street to a point 29 metres north of its junction with Upper George Street Part 226 from a point 29 metres north of its junction with Upper George Street to a point 2 metres south of a point opposite the north side of its junction with Ontario Close Part 207 from a point 2 metres south of a point opposite the north side of its junction with Ontario Close to its junction with Russell Square
