

LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (Granby Street Traffic Regulation Order) (No.318) ORDER 2022

Leicester City Council ("the Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4, 45, 46, 47, 48, 49, 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act, hereby makes the following Order: -

- 1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (<u>Granby Street TRO</u>) (No 318.) Order 2022, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 11th July 2022
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - In Schedule 1 to the Principle Order revoke the existing Schedules relating to Granby Street Northampton Street Northampton Square
 - (ii) In Schedule 1 to the Principal Order insert Schedule 1 hereto in appropriate alphabetical order Granby Street Northampton Street Northampton Square
 - (iii) In Section 3 of the Principal Order after existing Part 138 insert Schedule 2 hereto
- Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.
 NVITNESS whereof the Council have caused the Common Seal of the Leicester City Council to be hereunto fixed this 6th July 2022.

Shedule 2

Part 139 Prohibition Of Entry And Driving, At All Times, All Motor Vehicles, (Except For permit holders at any time and except for loading or unloading 5am – 10am)

No person shall drive or cause or permit to be driven any motor vehicle at any time so as to enter, proceed or remain on any road or length of road to which this restriction is applied. Provided that this restriction shall not apply to permit holders at any time or to vehicles requiring to load or unload goods in the road or length of road specified or in any road or length of road only accessible via the road or

length of road specified between 5.00am and

10.00am.
