THE LEICESTER (OFF-STREET PARKING PLACES) CONSOLIDATION ORDER 2018 (MISCELLANEOUS AMENDMENTS) ORDER 2022 (NO. 322)

Leicester City Council ("the Council") in exercise of its powers under sections 32, 35 and 46(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act, hereby makes the following Order:

- 1. This Order may be cited as the Leicester (Off-Street Parking Places) Consolidation Order 2018 (Miscellaneous Amendments) Order 2022 (No.322), is included among Orders which may be cited as the Leicester (Off-Street Parking Places) Consolidation Order 2018 and comes into force on the 31st day of May 2022.
- 2. In this Order "the Principal Order" means the Leicester (Off-Street Parking Places) Consolidation Order 2018 as amended by the Leicester City Council (Off-Street Parks, Leicester) (Articles/Interpretations for Additional Method of Payment (Pay by Phone)) Minor Order 2022) and by any other Order.
- 3. Any document referring to the Principal Order is to be construed as referring to the Principal Order as amended by this Order.
- 4. The Principal Order is amended as follows—
- (a) In Part 1, under the cross-heading "Interpretation", in article 3—
 - (i) after the definition of "the 2000 Regulations" insert the following definition—

 "the 2022 Regulations" means The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022 (S.I. 2022/71)";
 - (ii) omit the definition of "the 2007 Regulations";
 - (iii) omit the definition of "the 2007 Order";
 - (iv) for the definition of "Authorised Officer" substitute—
 - "authorised officer" means a Civil Enforcement Officer or any other individual authorised by the Council for the purposes of the authorisation to supervise and enforce the operation of a Car Park or any part thereof.";
 - in the definition of "Disabled Person's Badge" and "Holder", for "the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000" substitute "the 2000 Regulations";
 - (vi) omit the definition of "Grace Period"
 - (vii) omit the definition of "Higher Level Contraventions";
 - (viii) omit the definition of "Lower Level Contraventions";
 - (ix) omit the definition of "Parking Contravention";

- (x) for the definition of "Penalty Charge" and "Reduced Penalty Charge" substitute—

 ""penalty charge" means a penalty charge which is payable to the Council in accordance with the 2022 regulations, following the giving of notification of a penalty charge in accordance with those regulations.";
- (xi) omit the definition of "Penalty Charge Notice or PCN";
- (xii) omit the definition of "Relevant Legislation";
- (xiii) omit the definition of "Serve";
- (xiv) omit the definition of "Vehicle Immobilisation and Removal".
- (b) In Part IV (Restrictions on Use of Parking Spaces) omit article 16.
- (c) Omit Part VI (Penalty Charge for use of Car Parks).
- 5. Nothing in this Order affects the Principal Order in its operation in relation to contraventions committed before the commencement of this Order.
