THE LEICESTER CITY COUNCIL (KNIGHTON AREA, LEICESTER) (PROHIBITION OF DRIVING, ONE-WAY STREETS, STOPPING, WAITING AND FOOTWAY PARKING RESTRICTIONS) EXPERIMENTAL TRAFFIC ORDER 2022 (MISCELLANEOUS AMENDMENTS) ORDER 2022 (NO. 326)

Leicester City Council ("the Council") in exercise of its powers under sections 9, 10, and 11 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act, hereby makes the following Order:

- This Order shall come into force for all purposes on the 31st day of May 2022 and may be cited as the Leicester City Council (Knighton Area, Leicester) (Prohibition of Driving, One-Way Streets, Stopping, Waiting and Footway Parking Restrictions) Experimental Traffic Regulation Order 2022 (Miscellaneous Amendments) Order 2022 (No.326).
- 2. In this Order "the Principal Order" means the Leicester City Council (Knighton Area, Leicester) (Prohibition of Driving, One-Way Streets, Stopping, Waiting and Footway Parking Restrictions) Experimental Traffic Regulation Order 2022 as amended.
- 3. Any document referring to the Principal Order is to be construed as referring to the Principal Order as amended by this Order.
- 4. The Principal Order is amended as follows—
- (a) In article 2 of section 1 (Interpretation)—
 - (i) omit the definition of "Approved Device";
 - (ii) omit the definition of "Authorised Officer";
 - (iii) for the definition of "Contravention" substitute-

""Contravention" means a failure to comply with a restriction set out in this Order that may result in notification being given of a penalty charge in accordance with regulations made under section 78 of the Traffic Management Act 2004."

- (iv) omit the definition of "Date of Issue";
- (v) omit the definition of "Date of Service";
- (vi) omit the definition of "Detection Date";
- (vii) omit the definition of "Immobilisation Device";
- (viii) for the definition of "legally qualified medical practitioner" substitute-

""Legally Qualified Medical Practitioner" means a registered medical practitioner who holds a licence to practise.";

- (ix) omit the definition of "Penalty Charge and "Reduced Penalty Charge";
- (x) omit the definition of "Penalty Charge Notice or PCN";

- (xi) omit the definition of "Relevant Legislation";
- (xii) omit the definition of "Serve";
- (xiii) omit the definition of "Vehicle Immobilisation and Removal".
- (b) In article 2(i) of section 1 (Statutory references)-
 - (i) omit the definition of "Approved Devices Regulations";
 - (ii) omit the definition of "Levels of Charge Order";
 - (iii) omit the definition of "Parking Regulations";
 - (iv) omit the definition of "Representations and Appeals Regulations".
- (c) Omit section 10 (Contraventions & Enforcement of Restrictions Imposed by This Order).

5. Nothing in this Order affects the Principal Order in its operation in relation to contraventions committed before the commencement of this Order.
