THE LEICESTER CITY COUNCIL (VARIOUS STREET, LEICESTER) (MANDATORY NO STOPPING – SCHOOL ENTRANCE CLEARWAY) TRAFFIC REGULATION ORDER 2019 (MISCELLANEOUS AMENDMENTS) ORDER 2022 (NO. 328)

Leicester City Council ("the Council") in exercise of its powers under Sections 1, 2, 3, 4 and 5 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers including the Traffic Management Act 2004 as amended (whether generally or in relation to the area of the Council), and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act, hereby makes the following Order:

- This Order may be cited as the Leicester City Council (Various Streets, Leicester) (Mandatory No Stopping – School Entrance Clearway) Traffic Regulation Order 2019 (Miscellaneous Amendments) Order 2022 (No.328) and comes into force on the 31st day of May 2022.
- In this Order "the Principal Order" means the Leicester City Council (Various Streets, Leicester) (Mandatory No Stopping – School Entrance Clearway) Traffic Regulation Order 2019 as amended.
- 3. Any document referring to the Principal Order is to be construed as referring to the Principal Order as amended by this Order.
- 4. The Principal Order is amended as follows—
- (a) In Section 1 (General) in article 2—
 - (i) omit the definition of "Approved Device";
 - (ii) for the definition of "Contravention" substitute—
 - "contravention" means a failure to comply with a restriction set out in this Order that may result in notification being given of a penalty charge in accordance with regulations made under section 78 of the Traffic Management Act 2004.";
 - (iii) omit the definition of Civil Enforcement Officer" or "CEO";
 - (iv) omit the definition of "Immobilisation device";
 - (v) for the definition of "Legally qualified medical practitioner" substitute—
 - ""legally qualified medical practitioner" means a registered medical practitioner who holds a licence to practise.";
 - (vi) omit the definition of "Owner";
 - (vii) omit the definition of "Parking Regulations";
 - (viii) omit the definition of "Penalty charge" and "reduced penalty charge";
 - (ix) omit the definition of "Penalty Charge Notice (PCN)";
 - (x) omit the definition of "Permitted hours".

- (b) In Section 1 (General) in article 3—
 - (i) in paragraph (ii) for "Section 2, 3, 4, 5 or 6" substitute "Section 6";
 - (ii) in paragraph (iii) for "Sections 2, 3, 4, 5 or 6" substitute "Section 6".
- (c) Omit section 10 (Contraventions & Enforcement of Restrictions Imposed By This Order).
- 5. Nothing in this Order affects the Principal Order in its operation in relation to contraventions committed before the commencement of this Order.
