



**LEICESTER CITY COUNCIL**  
**THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006**  
**(AMENDMENT) (St George street Traffic Regulation Order) (No.331) ORDER 2022**

Leicester City Council ("the Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4, 45, 46, 47, 48, 49, 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act, hereby makes the following Order: -

1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (St George Street TRO) (No 331.) Order 2022, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 16<sup>th</sup> September 2022
  2.
    - (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006" as amended.
    - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
  3. The Principal Order shall be amended as follows:
    - (i) In Schedule 1 to the Principle Order revoke the existing Schedules relating to  
St George Street  
Queen Street
    - (ii) In Schedule 1 to the Principal Order insert Schedule 1 hereto in appropriate alphabetical order  
  
St George Street  
Queen Street
    - (iii) In Section 3 of the Principal Order after existing Part 139 insert Schedule 2 hereto
  4. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

### **St George Street**

Part 100      from its junction with Queen Street to its junction with St Georges Way in that direction

#### **Both Sides**

Part 140      From its junction with Queen Street to its junction with St Georges Way

#### **North-west Side**

Part 207      from its junction with Southampton Street to a point 10 metres south of its junction with Southampton Street

Part 211      from a point 10 metres south of its junction with Southampton Street to a point 10 metres north of its junction with Queen Street

Part 207      from a point 10 metres north of its junction with Queen Street to its junction with Queen Street

Part 200      from its junction with Queen Street to its junction with St Georges Way

#### **South-east Side**

Part 200      from its junction with St Georges Way to its junction with Queen Street

Part 207      from its junction with Queen Street to its junction with Southampton Street

## **Queen Street**

- Part 100 from its junction with St George's Way to its junction with St George Street in that direction
- Part 109 Prohibition Of Entry into Queen Street at its junction with Rutland Street
- Part 102 from Queen Street eastbound into St George Street southbound

### **North Side**

- Part 207 from its junction with Rutland Street to a point 20 metres east of its junction with Rutland Street
- Part 404 from a point 20 metres east of its junction with Rutland Street to a point 54 metres east of its junction with Rutland Street
- Part 207 from a point 54 metres east of its junction with Rutland Street to a point 71 metres east of its junction with Rutland Street
- Part 404 from a point 71 metres east of its junction with Rutland Street to a point 80 metres east of its junction with Rutland Street
- Part 207 from a point 80 metres east of its junction with Rutland Street to its junction with St George Street
- Part 207 from its junction with St George Street to a point 40 metres east of its junction with St George Street
- Part 404 from a point 40 metres east of its junction with St George Street to a point 60 metres east of its junction with St George Street
- Part 207 from a point 60 metres east of its junction with St George Street to its junction with St Georges Way

#### South Side

- Part 207 from its junction with St Georges Way to a point 20 metres west of its junction with St Georges Way
- Part 404 from a point 20 metres west of its junction with St Georges Way to a point 55 metres west of its junction with St Georges Way
- Part 207 from a point 35 metres east of its junction with St George Street to a point 25 metres west of its junction with St George Street
- Part 404 from a point 25 metres west of its junction with St George Street to a point 50 metres west of its junction with St George Street
- Part 207 from a point 50 metres west of its junction with St George Street to a point 62 metres west of its junction with St George Street
- Part 313 from a point 62 metres west of its junction with St George Street to a point 76 metres west of its junction with St George Street
- Part 207 from a point 76 metres west of its junction with St George Street to a point 103 metres west of its junction with St George Street
- Part 314 from a point 103 metres west of its junction with St George Street to a point 125 metres west of its junction with St George Street
- Part 207 from a point 125 metres west of its junction with St George Street to its junction with Rutland Street

Part 140	<b>Prohibition Of Entry And Driving, At All Times, All Motor Vehicles, (Except For emergency services and egress from the Mercury Place car park)</b> No person shall drive or cause or permit to be driven any motor vehicle at any time so as to enter, proceed or remain on any road or length of road to which this restriction is applied.
