LEICESTER CITY COUNCIL (CONSOLIDATION ORDER 2006) (AMENDMENTS) (BELGRAVE GATE, EAST GATES & HAYMARKET) TRAFFIC REGULATION ORDER 2022 (No.332)

Leicester City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 5, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and being satisfied that, for the reasons specified in Section 3(2)(a), (b), (d), and (e) of the Act, it is requisite that subsection (1) of Section 3 of the Act should not apply to this Order, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. This Order may be cited as the Leicester (Consolidation Order 2006) (Amendments) (Belgrave Gate, East Gates & Haymarket) Traffic Regulation Order 2022 (No.332) and shall be included among Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 14 September 2022.
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006" as amended.
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the existing schedules of any length(s) of the following roads specified in this Order

Belgrave Gate East Gates Haymarket

(ii) In schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order.

- (iii) In section 3 of the Principal Order entitled Waiting Restrictions after part 264 insert Schedule 2 to this order
- (iv) In section 4 of the Principal Order entitled Parking Place Restrictions after part 323 insert Schedule 3 to this order
- 4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order.
