



**LEICESTER CITY COUNCIL**  
**THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006**  
**(AMENDMENT) (Beauville Drive) (No.334) ORDER 2022**

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4 and 5 of the Road Traffic Regulation Act 1984 (the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and being satisfied that, for the reasons specified in Section 3(2)(a), (b), (d), and (e) of the Act, it is requisite that subsection (1) of Section 3 of the Act should not apply and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order in Part:-

: -

1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Beauville Drive) (No 334.) Order 2022, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 12<sup>th</sup> September 2022
  2.
    - (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006" as amended.
    - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
  3. The Principal Order shall be amended as follows:
    - (i) In Schedule 1 to the Principle Order revoke the existing Schedules relating to Beauville Drive
    - (ii) In Schedule 1 to the Principal Order insert Schedule 1 hereto in appropriate alphabetical order  
Beauville Drive
  4. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

## **SCHEDULE 1**

### **Beauville Drive**

#### **Inner Side**

- Part 207 from its junction with Strasbourg Drive to a point 10 metres south-west of its junction with Strasbourg Drive
- Part 250 from a point 10 metres south-west of its junction with Strasbourg Drive to a point 5 metres northeast of its junction with Badgers Close
- Part 207 from a point 5 metres northeast of its junction with Badgers Close to a point 5 metres south-west of its junction with Badgers Close
- Part 250 from a point 5 metres south-west of its junction with Badgers Close to a point 25 metres south west of the boundary of Nos. 14/16 Beauville Drive
- Part 207 from a point 25 metres south west of the boundary of Nos. 14/16 Beauville Drive to a point 5 metres north of the boundary of Nos 18/20 Beauville Drive
- Part 250 from a point 5 metres north of the boundary of Nos 18/20 Beauville Drive to the boundary of Nos. 1/3 Beauville Drive

#### **Outer Side**

- Part 250 from the boundary of Nos. 1/3 Beauville Drive to a point 10 metres south-west of its junction with Strasbourg Drive
- Part 207 from a point 10 metres south-west of its junction with Strasbourg Drive to its junction with Strasbourg Drive
- Part 504 From a point opposite the boundary of Nos. 18/20 Beauville Drive to a point opposite 17 metres south-west of the boundary of Nos. 14/16 Beauville Drive
- Part 504 from a point opposite 2 metres south-west of the boundary of Nos. 10/12 Beauville Drive to a point opposite 7 metres south-west of the boundary of Nos. 2/4 Beauville Drive.
