



**LEICESTER CITY COUNCIL  
THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006  
(AMENDMENT) (CHURCH GATE) LEICESTER (No 337) ORDER 2022**

Leicester City Council (the Council) in exercise of their powers under Section 1, 2, 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Church Gate) Leicester (No 337) Order 2022 And shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 19 October 2022.
2.
  - (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
  - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
  - (i) In Schedule 1 to the Principal Order revoke the existing Schedules relating to  
  
Church Gate
  - (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order.
4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

All other restrictions on Church Gate will remain unchanged

## SCHEDULE 1

### CHURCH GATE

- Part 127 Prohibition of entry and driving at any time all motor vehicles except permit holders and except loading Sunday to Friday 5am to 11am and except loading Saturday 5am to 9am from its junction with East Gates to its junction with Mansfield Street
- Part 128 One-way street from its junction with East Gates to a point 60 metres in a northerly direction
- Part 128 From its junction with Vaughan Way to its junction with Gravel Street in that direction
- Part 128 From its junction with Mansfield Street /St Peters Lane to a point 16 metres southeast of its junction with Gravel Street

#### North-east Side

- Part 200 From its junction with Burleys Way to a point 5m south of its junction with Gravel Street
- Part 309 From a point 5m south of its junction with Gravel Street to a point 22m south of its junction with Gravel Street
- Part 200 From a point 22m south of its junction with Gravel Street to point 29m south of its junction with Gravel Street
- Part 400 From a point 29m south of its junction with Gravel Street to a point 42m south of its junction with Gravel Street
- Part 200 From a point 42m south of its junction with Gravel street to a point 53m south of its junction with Gravel Street
- Part 400 From a point 53m south of its junction with Gravel Street to a point 66m south of its junction with Gravel Street
- Part 200 From a point 66m south of its junction with Gravel Street to its northern junction with Mansfield Street a distance of 35m
- Part 233 From its southern junction with Mansfield Street to its junction with East Gates

### South-west Side

- Part 233 From its junction with East Gates to its northern junction with St Peter's Lane
- Part 200 From its northern junction with St Peters Lane to its junction with Vaughan Way
