



LEICESTER CITY COUNCIL
THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006
(AMENDMENT) (DISCOVERY ROAD) (No.282) ORDER 2020

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under sections 1, 2, 32, 35, 45, 46, 46A, 49, 51, 53 and 63A of the Road Traffic Regulation Act 1984 ("the 1984 Act") and of Part IV of Schedule 9 to the 1984 Act and of all other enabling powers including the Road Traffic Act 1991 as amended (whether generally or in relation to the area of the Council) ("the 1991 Act") and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the 1984 Act hereby make the following Order:-

1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Discovery Road) (No.282) Order 2020 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into operation on the 13th day of January 2020.
2.
 - (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order insert Schedule 1 hereto in the appropriate alphabetical order
 - (ii) In Section 2 of Schedule 2 of the Principal Order after the entry 2.8 for The Coleman Road Service Road residents' parking Zone H, insert Schedule 2 hereto
 - (iii) In Section 5 of the Principal Order entitled Designated Parking Place Restrictions after Part 417 insert Schedule 3 hereto

Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order

SCHEDULE 1

Ariane Place

Both sides

Part 418 from its junction with Discovery Road to its western and southern extent including the turning head

North Side

Part 207 from its junction with Discovery Road to a point 5 metres west of its junction with Discovery Road

Part 207 from a point 15 metres west of its junction with Discovery Road to a point 48 metres west of its junction with Discovery Road

South Side

Part 207 from a point 5 metres west of its junction with Discovery Road to its junction with Discovery Road

Beagle Close

Both sides

Part 418 from its junction with Discovery Road to its eastern and northern extent including the turning head

North Side

Part 207 from its junction with Discovery Road to a point 5 metres east of its junction with Discovery Road

Part 207 from a point 5 metres east of its junction with Discovery Road to its junction with Discovery Road

Discovery Road

Both sides

- Part 418 from its junction with Exploration Drive to its southern extent including the turning head

East Side

- Part 207 from its junction with Exploration Drive to a point 13 metres south of its junction with Exploration Drive
- Part 207 from a point 5 metres north-west of its junction with Beagle Close to a point 5 metres south of its junction with Beagle Close

West Side

- Part 207 from a point 5 metres south of its junction with Ariane Place to a point 5 metres north-west of its junction with Ariane Place
- Part 207 from a point 10 metres south of its junction with Exploration Drive to its junction with Exploration Drive

SCHEDULE 2

SECTION 2 RESIDENTS PARKING ZONE

- 2.9 The Discovery Road residents' parking area shall be referred to as Zone J.

Zone J residents parking permits shall only be issued to residents of properties whose address is included in the following list:

Ariane Place, all properties
Beagle Close, all properties
Discovery Road, all properties
51, 53 and 55, Exploration Drive

Zone J residents parking place permits shall be valid for use in the following roads, except where other restrictions are in place:-

Ariane Place
Beagle Close
Discovery Road

SCHEDULE 3

Designated Residents Parking.

No person shall cause or permit a vehicle to wait between 9am – 4pm Monday to Friday on any of the roads or lengths of road specified to which this restriction is applied except a vehicle displaying a residents parking permit or a visitors permit valid for the zone in which the residents parking is located, the zone reference letter being indicated on the traffic signs. Provided that this restriction shall not apply to a vehicle displaying a disabled persons badge issued and displayed in accordance with the “Disabled Persons (Badges For Motor Vehicles) (England) Regulations 2000” and includes similar badges issued by other European Member States. No person shall carry out any work relating to the construction or repair of the vehicle other than may be necessary to enable the vehicle to be moved from the residents parking. No person shall allow a vehicle waiting in the residents parking to be used for or in connection with the sale of any vehicle or any other article or for the offer of any service for reward. Residents and visitor permits shall be issued in accordance with the rules contained in section 8 and schedule 2 of this order.
