# THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (LONDON ROAD AREA) (NO. 5) ORDER 2007

LEICESTER CITY COUNCIL (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and have all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby makes the following Order:-

- (1) This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (London Road Area) (No. 5) Order 2007 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into operation on 19th day of February 2007.
- (2) (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006".
  - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- (3) The Principal Order shall be amended as follows: In the First Schedule to the Order remove the Schedules relating to Holmfield Road, Knighton Park Road, London Road and Shirley Road and replace with the Schedules hereto.
- (4) Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order.

IN WITNESS whereof the Council have caused the Common Seal of Leicester City Council to be hereunto affixed this 14th day of February 2007.

# EXPLANATORY NOTE (this does not form part of the Order)

The effect of this Order is to consolidate existing manoeuvre and waiting restrictions already in force in the streets listed in the above schedules into The Leicester (Consolidation) Traffic Regulation Order 2006 together with changes to waiting and loading restrictions in those same streets listed in the above schedules. To also revoke certain existing waiting restrictions on a length of service road in London Road near to Mayfield Road roundabout that has now been integrated into the main carriageway, as a consequence of which, the waiting restrictions are no longer required as they have been replaced by those relating to the main carriageway on London Road.
