THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT)(GOUGH ROAD)(NO.11) ORDER 2007

LEICESTER CITY COUNCIL (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and have all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

- (1) This Order may be cited as "The Leicester (Consolidation) Traffic Regulation Order 2006(Amendment)(Gough Road)(No.11) Order 2007" and shall be included amongst the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 23rd day of July 2007.
- (2) (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006".
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- (3) The Principal Order shall be amended as follows: In Schedule 1 to the Order remove the Schedule relating to Gough Road and replace with the Schedule hereto.
- (4) Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order.
