

LEICESTER CITY COUNCIL THE LEICESTER TRAFFIC REGULATION (ALLANDALE ROAD AND FRANCIS STREET) (EXPERIMENTAL) ORDER 2007

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Section 9 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

- This Order may be cited as the Leicester Traffic Regulation (Allandale Road and Francis Street) (Experimental) Order 2007 and shall come into operation on 28th November 2007, and remain in force for a period of 18 months.
- 2. The waiting restrictions on those lengths of Allandale Road and Francis Street as specified in the Schedule hereto are hereby suspended for the duration of the Order.
- 3. This Order may be modified or suspended by the Director of Regeneration, Highways and Transportation, if it appears to him essential in the interests of the expeditious, convenient and safe movement of traffic or of the provision of suitable and adequate parking facilities on the highway in accordance with Section 10(2) of the Act.

ALLANDALE ROAD

North-east Side

the layby, from its junction with Francis Street to a point 42 metres southeast of its junction with Francis Street

from a point 42 metres south-east of its junction with Francis Street to a point 36 metres north-west of its junction with Stoughton Road

from a point 21 metres north-west of its junction with Stoughton Road to a point 3 metres north-west of its junction with Stoughton Road

South-west Side

the limited waiting parking box, from a point 82 metres south-east of its junction with Francis Street to a point 69 metres south-east of its junction with Francis Street

the limited waiting parking box, from a point 63 metres south-east of its junction with Francis Street to a point 52 metres south-east of its junction with Francis Street

the layby, from a point 36 metres south-east of its junction with Francis Street to a point 3 metres south-east of its junction with Francis Street

FRANCIS STREET

North-west Side

from a point 9 metres north-east of its junction with Stoneygate Road to a point 25 metres north-east of its junction with Stoneygate Road

from a point 35 metres north-east of its junction with Stoneygate Road to a point 125 metres north-east of its junction with Stoneygate Road

from a point 130 metres north-east of its junction with Stoneygate Road to a point 140 metres north-east of its junction with Stoneygate Road

from a point 146 metres north-east of its junction with Stoneygate Road to a point 160 metres north-east of its junction with Stoneygate Road
