



THE LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (HIGHFIELDS SOUTH RESIDENTS PARKING AREA) (NO.25) ORDER 2008

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

- This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment)(Highfields South Residents Parking Area) (No.25) Order 2008, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 4th August 2008.
- 2. (i) The expression "the Principal Order" means " The Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order insert Schedule 1 hereto in the appropriate alphabetical order.
 - (ii) Delete Schedule 2 of the Principal Order and insert Schedule 2 hereto
 - (iii) In Section 4 of the Principal Order entitled Parking Place Restrictions after part 309 insert Schedule 3 hereto
 - (iv) In Section 5 of the Principal Order entitled Designated Parking Place Restrictions after part 407 insert Schedule 4 hereto
- 4. Revoke all the restrictions in the Leicester (Consolidation) Traffic Regulation Order 1975("the 1975 Order") and its subsequent amendments in so far as they impose restrictions on the following roads. Restrictions imposed by the 1975 Order on other roads will remain in force.

SCHEDULE 2 PERMITS

SECTION 1 RESIDENTS PARKING PLACE PERMITS

1.1 Each area of the City where a scheme is introduced to afford special parking provision for local residents shall be assigned a residents parking zone identification letter. Traffic signs bearing the identification letter shall be used to show the parking places covered by the residents parking scheme. Permits issued to residents or visitors to allow the use of the parking places shall bear the zone

identification letter. Permits shall only be valid for the use of parking places bearing the same zone identification letter as is shown on the permit. The zone letter, addresses of properties where a resident qualifies for a permit for the zone bearing that letter and the streets where residents parking places for that zone are located are as defined in section 2 of this schedule.

- 1.2 Residents parking permits or visitor permits shall only be issued to a person who can prove to the satisfaction of the officer responsible for the issuing of such permits that they are a permanent resident of a property where residency qualifies a person to receive such a permit and in the case of a residents parking permit for zone A only, that they do not have access to off street parking facilities at that address.
- 1.3 Residents parking permits shall only be issued to residents who can prove to the satisfaction of the officer responsible for the issuing of such permits that they are the owner or keeper of the vehicle for which the permit is being applied for.
- 1.4 Residents parking permits shall only be issued for vehicles which are passenger vehicles constructed or adapted to carry not more than 8 passengers exclusive of the driver, goods vehicles or motor cycles. In respect of Zone B goods vehicle means a vehicle not exceeding 3.5 tonnes.
- 1.5 Each person may only be issued with one residents parking permit.
- 1.6 Residents permits, visitor permits, Business Permits and Customer Permits shall only be issued upon receipt by the officer responsible for the issuing of such permits of the appropriate fee as defined in section 6 of this schedule provided that a residents parking permit may be issued free of charge to a resident who is a disabled badge holder.
- 1.7 With respect to residents of properties qualifying for a residents parking permit where it can be proved to the satisfaction of the officer responsible for the issuing of such permits that the resident requires the attendance on a regular basis of a carer, medical attendant or counsellor that a special visitor permit may be issued free of charge to that carer, medical attendant or counsellor. Special visitor permits may be valid at all times or at such times as may be specified on the permit.
- 1.8 The maximum number of visitor parking permits which may be issued to an individual applicant on any one day shall be 5 and not more than 5 permits shall be issued in any consecutive period of 2 days.
- 1.9 Residents visitor parking permits issued by the City Council must not be resold or passed on to a third party who is not a bona fide visitor to a residential property within the residents parking zone specified on the permit.

- 1.10 Any person found to be supplying a resident visitor parking permit to persons other than bona fide visitors to residential properties in the residents parking zone specified on the permit shall forfeit their rights to purchase further visitor parking permits and shall be required to surrender any unused visitor parking permits still in their possession.
- 1.11 Any person who proves to the satisfaction of the officer responsible for the issuing of residents parking permits that they have lost damaged or had stolen residents parking permit may be issued with a replacement permit free of charge provided that the original permit shall be canceled and shall immediately cease to be valid.
- 1.12 Residents parking permits no longer required may be returned to the City Council who will then refund a sum of money equivalent to one twelfth of the original purchase price of the permit for each full calendar month for which the permit remains valid.
- 1.13 Residents parking permits and visitors permits displayed in a vehicle not being a vehicle belonging to a bona fide resident or visitor shall be deemed to be invalid.
- 1.14 Where it appears to the officer responsible for the issuing of residents parking permits and visitor permits that such permits have been issued or are or have been used in a manner contrary to the conditions set out in this schedule the officer may require the return of the permits to the Council forthwith.
- 1.15 Residents parking permits, Business Permits and Customer Permits shall normally be valid for a maximum period of 12 months from the date of issue. Permits may be issued valid for longer or shorter periods when officers consider it expedient to do so.
- 1.16 In the Bede Island North residents Parking Zone permits shall be limited to one permit per household provided that this condition may be varied by the officer responsible for the issuing of permits with the agreement of the housing association responsible for that development.
- 1.17 With respect to residents parking places in zone E (Highfields South) and, unless otherwise stated, for all other residents parking zones that may be introduced after 4th August 2008. The City Council may issue Business Parking Permits and Customer Permits for use by businesses associated with the repair or servicing of motor vehicles. Such permits shall be valid for use only in the resident's zone in which the business is located.
- 1.18 Business Permits and Customer Permits shall only be valid for the period 7.30am to 6.00pm Monday to Saturday. Business Permits shall only be issued for vehicles necessary for the operation of the

business.

- 1.19 The number of Business Permits issued to each business shall be limited according to the nature of the business and the parking standards applicable for Development Control purposes at the time that the residents parking scheme is introduced. The number of permits available to any particular business is limited to the number of off street parking spaces that would be permitted to be provided if planning consent was given for that business at the time that the scheme is introduced based on the criteria for the central commercial zone (zone 2). The maximum level of parking for each class of business use being specified in the Supplementary Planning Guidance that accompanies the Local Plan. Provided that any existing off street parking provision available to that business is taken into account and deducted from the maximum number of permits that business is allowed to purchase. The deduction of existing parking places shall not include the workshop areas of businesses associated with the servicing or repair of motor vehicles.
- 1.20. Business Permits shall be provided in areas of new residents parking schemes where planning consent for that business use is in force at the time that the residents parking scheme is introduced and not for subsequent new development or changes of use that take place after a residents parking scheme for the area has been introduced.
- 1.21 For businesses associated with the repair or servicing of motor vehicles a maximum of 3 Customer Permits per business shall be provided for the parking of customers vehicles awaiting service, repair or collection.

SECTION 2 RESIDENTS PARKING ZONES

2.1 The Holy Trinity residents parking area shall be referred to as Zone A.

SECTION 3 DOCTORS PARKING PERMITS

- 3.1 The City Council may from time to time introduce on a road by means of a traffic regulation order parking bays for the exclusive use of doctors either at all times or at such times as may be specified in the order. Only vehicles used by a doctor and for which the City Council has issued a doctors parking permit may wait in a doctor parking place during its hours of operation
- 3.2 Doctor parking permits shall only be issued to a legally qualified medical practitioner upon receipt of the fee set out in section 6 of this schedule and subject to the officer responsible for the issue of the permit being satisfied that the person is a legally qualified practitioner and that they are the owner, keeper or user of the vehicle for which the permit has been requested. Only qualified medical practitioners who are liable to be called, of necessity, to emergencies away from the surgery or consulting room located in the proximity of the doctor parking place shall be issued with a doctor parking permit.
- 3.3 Any doctor who proves to the satisfaction of the officer responsible for the issuing of doctors parking permits that they have lost, damaged or had stolen a doctors parking permit may be issued with a replacement permit free of charge provided that the original permit shall be canceled and shall immediately cease to be valid.
- 3.4 Doctors parking permits no longer required may be returned to the City Council who will then refund a sum of money equivalent to one

- twelfth of the original purchase price of the permit for each full calendar month for which the permit remains valid.
- Where it appears to the officer responsible for the issuing of doctor parking permits that such a permit has been issued or is or has been used in a manner contrary to the conditions set out in this schedule may require the return of the permit to the Council forthwith.
- 3.6 Doctor parking permits shall be valid for a maximum period of 12 months from the date of issue.

SECTION 4 PERMITS TO ALLOW DELIVERY OF PERISHABLE GOODS IN GALLOWTREE GATE, HUMBERSTONE GATE & FOX LANE

4.1 A permit to allow a vehicle to enter and to load or unload in Gallowtree Gate, Humberstone Gate (section between Charles Street and the Clock Tower) or Fox Lane contrary to the pedestrian zone and waiting / loading prohibitions may be issued to allow the delivery of perishable foods. Provided that a permit shall only be issued to allow delivery or collection from businesses operating in those streets on 25th September 1996. Permits to be issued free of charge.

SECTION 5 PERMITS TO ALLOW USE OF DESIGNATED PARKING BAYS CONTRARY TO THE NORMAL PARKING CONDITIONS.

- When satisfied that it is necessary for a vehicle to be parked in a designated parking bay in a manner contrary to the normal conditions a parking attendant or a person appointed by the Council may issue a permit to allow the vehicle to be so parked. Such a permit may be issued free of charge and may only be issued for a period of up to 24 hours expiring at midnight on the day of issue. No further permit of the same type for use by the same vehicle may be issued for a period of 48 hours following the expiry of the initial permit.
- Where a vehicle is required to be parked in a designated parking bay contrary to the normal conditions for a period exceeding 24 hours an application must be made to the Council. A person appointed by the Council may issue a permit provided that he or she is satisfied that it is necessary to do so and may issue such a permit free of charge or for such fees as the Council may from time to time determine and as specified in section 6 of this schedule.

SECTION 6 CHARGES FOR PERMITS

6.1 With effect from 4th August 2008 the cost of all forms of permits will be as determined from time to time by the Council and published as a list of permit charges available to the public.

No person shall cause or permit a vehicle to wait between midnight - 7.30am and 6.00pm - midnight Monday to Saturday on any of the roads or lengths of road specified to which this restriction is applied except a vehicle displaying a residents parking permit or a visitors permit valid for the zone in which the parking place is located, the zone reference letter being indicated on the traffic sign indicating the restriction applicable to that parking place. Provided that this restriction shall not apply to a vehicle displaying a disabled persons blue badge issued and displayed in accordance with the "The Disabled Persons (Badges on Vehicles) Regulations 1982" or a disabled persons blue parking card issued in accordance with the rules of any member State of the European Community. Vehicles must be parked wholly within the parking bay as marked on the carriageway. Whilst parked in the residents parking bay no person shall carry out any work relating to the construction or repair of the vehicle other than may be necessary to enable the vehicle to be moved from the parking bay. No person shall allow a vehicle waiting in a residents parking bay to be used for or in connection with the sale of any vehicle or any other article or for the offer of any service for reward. Residents and visitor permits shall be issued in accordance with the rules contained in section 8 and schedule 2 of this order.
