

THE LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (ALLANDALE ROAD AND FRANCIS STREET) (NO.42) ORDER 2009

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

- 1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Allandale Road and Francis Street) (No.42) Order 2009 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 23rd February 2009.
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 of the Principal Order revoke the existing Schedules relating to

ALLANDALE ROAD FRANCIS STREET

- (ii) In Schedule 1 of the Principal Order insert Schedule 1 hereto in the appropriate alphabetical order.
- 4. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order

Schedule 1

ALLANDALE ROAD



Part 100 One Way Street from its junction with Stoughton Road to its junction with Francis Street, in that direction

North-east Side

- Part 207 from its junction with Francis Street to a point 42 metres south-east of its junction with Francis Street, excluding the layby between its junction with Francis Street to 42 metres south-east of its junction with Francis Street
- Part 207 from a point 36 metres north-west of its junction with Stoughton Road to a point 21 metres north-west of its junction with Stoughton Road
- Part 207 from a point 3 metres north-west of its junction with Stoughton Road to its junction with Stoughton Road

South-west Side

Part 207 from its junction with Stoughton Road to its junction with Francis Street, excluding the parking boxes between 82 metres and 69 metres south-east of its junction with Francis Street and 63 metres and 52 metres south-east of its junction with Francis Street, and the layby between 36 metres and 3 metres south-east of its junction with Francis Street

FRANCIS STREET

Part 100 One Way Street from its junction with Allandale Road to its junction with Stoneygate Road, in that direction

North-west Side

Part 207 from its junction with Stoneygate Road to a point 9 metres northeast of its junction with Stoneygate Road

Part 207 from a point 25 metres north-east of its junction with Stoneygate Road to a point 35 metres north-east of its junction with Stoneygate Road Part 207 from a point 125 metres north-east of its junction with Stoneygate Road to a point 130 metres north-east of its junction with Stoneygate Road Part 207 from a point 140 metres north-west of its junction with Stoneygate Road to a point 146 metres north-west of its junction with Stoneygate Road South-east Side from the north-east side of its junction with Allandale Road to a point 7 metres south-west of its junction with Allandale Road from a point 7 metres south-west of its junction with Allandale Road Part 215 to a point 22 metres south-west of its junction with Allandale Road Part 207 from a point 22 metres south-west of its junction with Allandale Road to a point 28 metres south-west of its junction with Allandale Road Part 215 from a point 28 metres south-west of its junction with Allandale Road to a point 40 metres north-east of its junction with Stoneygate Road Part 207 from a point 40 metres north-east of its junction with Stonevgate Road to a point 34 metres north-east of its junction with Stoneygate Road Part 215 from a point 34 metres north-east of its junction with Stoneygate Road to a point 9 metres north-east of its junction with Stoneygate Road
