

THE LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (DULVERTON ROAD) (NO.45) ORDER 2009

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

- 1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment)(Dulverton Road) (No.45) Order 2009, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 11th March 2009.
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the existing Schedule relating to Dulverton Road.
 - (ii) In Schedule 1 to the Principal Order insert the Schedule hereto in appropriate alphabetical order
- 4. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

SCHEDULE

DULVERTON ROAD

Part 120	Prohibition of Entry except Cycles into Dulverton Road from Westcotes Drive
Part 207	North & West Side from its junction with Westcotes Drive to a point 21 metres east of its junction with Westcotes Drive
Part 207	from a point 15 metres south-west of its junction with Hinckley Road to its junction with Hinckley Road
Part 207	South & East Side from its junction with Hinckley Road to a point 15 metres south- west of its junction with Hinckley Road
Part 207	from a point 18 metres east of its junction with Westcotes Drive to its junction with Westcotes Drive

WESTCOTES DRIVE

East Side

Part 207 from a point 3 metres north of its junction with Dulverton Road to a point 5 metres south of its junction with Dulverton Road

Explanatory Note

Existing Restrictions in force on Westcotes Drive under any other Orders remain in force
