

THE LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (ST NICHOLAS PLACE AREA) (NO.63) ORDER 2009

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

- 1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment)(St Nicholas Place Area) (No.63) Order 2009, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 12th November 2009.
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006" as amended.
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the existing Schedule relating to:-

St Nicholas Place Carey Street Highcross Street

- (ii) In Schedule 1 to the Principal Order insert the Schedule hereto in appropriate alphabetical order
- 4. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

- Part 309 the lay by from a point 9 metres east of its junction with Vaughan Way to a point 37 metres east of its junction with Vaughan Way
- Part 305 the lay by from a point 9 metres east of its junction with Vaughan Way to a point 37 metres east of its junction with Vaughan Way

- Part 225 from a point 8 metres east of its junction with St Nicholas Place
 Main Carriageway to a point 48 metres east of its junction with St
 Nicholas Place Main Carriageway
- Part 304 from a point 8 metres east of its junction with St Nicholas Place
 Main Carriageway to a point 48 metres east of its junction with St
 Nicholas Place Main Carriageway
- Part 207 from a point 48 metres east of its junction with St Nicholas Place Main Carriageway to its junction with Guildhall Lane

South & West Side

- Part 207 from its junction with Careys Close to its junction with St Nicholas
 Place Main Carriageway excluding the lay by between 50 metres
 and 21 metres south east of its junction with St Nicholas Place
 Main Carriageway
- Part 303 the lay by from a point 50 metres south-east of its junction with St Nicholas Place Main Carriageway to a point 21 metres south-east of its junction with St Nicholas Place Main Carriageway

Part 100 One Way Street from its junction with Careys Close to its junction with St Nicholas Circle in that direction

North & East Side

- Part 200 from its junction with Careys Close to a point 14 metres north of its junction with Careys Close
- Part 400 from a point 14 metres north of its junction with Careys Close to a point 30 metres north of its junction with Careys Close
- Part 200 from a point 30 metres north of its junction with Careys Close to its junction with St Nicholas Circle

South & West Side

Part 200 from its junction with St Nicholas Circle to its junction with Careys Close

Part 207	North & West Side from its southern extremity to its junction with St Nicholas Place West
Part 200	from its junction with St Nicholas Place West to its junction with St Nicholas Place Link Road
Part 200	South & East Side from its junction with Guildhall Lane to a point 9 metres west of its junction with Guildhall Lane
Part 400	from a point 9 metres west of its junction with Guildhall Lane to a point 25 metres west of its junction with Guildhall Lane
Part 200	from a point 25metres west of its junction with Guildhall Lane to a point 38 metres west of its junction with Guildhall Lane
Part 400	from a point 38 metres west of its junction with Guildhall Lane to a point 54 metres west of its junction with Guildhall Lane
Part 207	from a point 54 metres west of its junction with Guildhall Lane to its southern extremity including the turning head

Part 102	Prohibited Right Turn north west bound from Highcross Street into Vaughan Way
Part 200	East Side from its junction with High Street to a point 43 metres south-east of its junction with Freeschool Lane
Part 202	from a point 43 metres south-east of its junction with Freeschool Lane to a point 33 metres south-east of its junction with Freeschool Lane
Part 207	from a point 33 metres south-east of its junction with Freeschool Lane to a point 5 metres north-west of its junction with Freeschool
