**THE LEICESTER TRAFFIC REGULATION (HUMBERSTONE GATE)**  
**(EXPERIMENTAL)**  
**TRAFFIC REGULATION ORDER 2009**

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Section 9 of the Road Traffic Regulation Act 1984 ("the Act") and of Parts I to IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-


1. This Order may be cited as the Leicester Traffic Regulation (Humberstone Gate) Traffic Regulation Order 2009 and shall come into force on the 27<sup>th</sup> November 2009 and remain in force for 18 months
2. (i) The expression "the Principal Order" means the Leicester Traffic (Consolidation) Traffic Regulation Order 2006  
  
(ii) The one way traffic restriction in force for Humberstone Gate as specified in the Principal Order and as detailed in the Schedule to this Order is hereby replaced by this Order for its duration. All other restrictions in relation to Humberstone Gate remain in force.
3. (i) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament  
  
(ii) For the Purpose of this Order:-

"One Way Traffic Restriction" means No person shall drive or cause or permit to be driven any vehicle on any length of road to which this restriction is applied otherwise than in the direction specified. Provided that this restriction shall not apply to a mechanical street cleansing vehicle between the hours of 11.00pm and 7.00am the following day. Provided also that it shall not be an offence or contravention to cause or permit a vehicle to enter or be driven in a manner contrary to this restriction provided that the person is acting upon the direction of a police constable in uniform or such other persons in uniform appointed for that purpose by the Chief Constable for Leicestershire.

- 4. A one way traffic restriction is hereby introduced in Humberstone Gate from its junction with Gallowtree Gate to its junction with Charles Street in that direction
- 5. This Order may be modified or suspended by the Director of Regeneration, Highways and Transport, if it appears to him essential in the interests of the expeditious, convenient and safe movement of traffic or of the provision of suitable or adequate parking facilities on the highway in accordance with Section 10(2) of the Act.
