THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER
2006 (AMENDMENT) (WINCHESTER AVENUE) (NO.64) ORDER 2009

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment)(Winchester Avenue) (No.64) Order 2009, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 4th January 2010 .
2.
 - (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the existing Schedule relating to:-

Winchester Avenue
 - (ii) In Schedule 1 to the Principal Order insert the Schedule hereto in appropriate alphabetical order
4. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

South-west Side

Part 207 from its junction with Narborough Road to a point 10 metres north-west of its junction with Narborough Road

Part 207 from a point 5 metres south-east of its junction with Lavender Road to a point 5 metres north-west of its junction with Lavender Road

Part 207 from a point 5 metres south-east of its junction with Sweetbriar Road to a point 5 metres north-west of its junction with Sweetbriar Road

Part 207 from a point 11 metres south-east of its junction with Fosse Road South to a point 6 metres north-west of its junction with Fosse Road South
