THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006
(AMENDMENT) (ST MICHAELS AVENUE) (NO.70) ORDER 2010

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment)(St Michaels Avenue) (No.70) Order 2010, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 1st of March 2010.
2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
(ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order insert the Schedule hereto in appropriate alphabetical order
4. Revoke all the restrictions in the Leicester (Consolidation) Traffic Regulation Order 1975 and its subsequent amendments in so far as they impose restrictions on the following roads.

Harrison Road - between its junction with Gipsy Lane/Marfitt Street and its northern extremity
Lancashire Street
St Michaels Avenue
Stafford Street


Restrictions imposed by that 1975 Order on other roads will remain in force.
5. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order.

HARRISON ROAD

North-west Side

- Part 204 from its junction with Marfitt Street to a point 13 metres north-east of its junction with Marfitt Street
- Part 207 from a point 3 metres south-west of its junction with St Michaels Avenue to a point 3 metres north-east of its junction with St Michaels Avenue
- Part 207 from a point 3 metres south-west of its junction with Lancashire Street to a point 3 metres north-east of its junction with Lancashire Street
- Part 207 from a point 3 metres south-west of its junction with Stafford Street to the north-east side of its junction with Stafford Street

South-east Side

- Part 207 from a point 10 metres north-east of its junction with Magnus Road to its junction with Magnus Road
- Part 204 from its junction with Magnus Road to its junction with Gipsy Lane

LANCASHIRE STREET

- Part 100 One Way Street from its junction with Melton Road to its junction with Harrison Road in that direction

North-east Side

- Part 207 from its junction with Melton Road to a point 10 metres south-east of its junction with Melton Road
- Part 207 from a point 3 metres north-west of its junction with Harrison Road to its junction with Harrison Road

South-west Side

Part 207 from its junction with Harrison Road to a point 3 metres north-west of its junction with Harrison Road

Part 207 from a point 10 metres south-east of its junction with Melton Road to its junction with Melton Road

MAGNUS ROAD

North-east Side

Part 207 from its junction with Harrison Road to a point 4 metres south-east of its junction with Harrison Road

South-west Side

Part 204 from a point 4 metres south-east of its junction with Harrison Road to its junction with Harrison Road

ST MICHAELS AVENUE

Part 100 One Way Street from its junction with Harrison Road to its junction with Melton Road in that direction

North-east Side

Part 207 from its junction with Melton Road to a point 10 metres south-east of its junction with Melton Road

Part 207 from a point 3 metres north-west of its junction with Harrison Road to its junction with Harrison Road

South-west Side

Part 207 from its junction with Harrison Road to a point 3 metres north-west of its junction with Harrison Road

Part 207 from a point 10 metres south-east of its junction with Melton Road to its junction with Melton Road

STAFFORD STREET

Part 100 One Way Street from its junction with Edensor Street to its junction with Melton Road

North-east Side

Part 207 from its junction with Melton Road to a point 10 metres south-east of its junction with Melton Road

Part 207 from a point 3 metres north-west of its junction with Harrison Road to its junction with Harrison Road

South-west Side

Part 207 from its junction with Harrison Road to a point 3 metres north-west of its junction with Harrison Road

Part 207 from a point 10 metres south-east of its junction with Melton Road to its junction with Melton Road
