

# THE LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (HUMBERSTONE GATE) (PART) (NO.78) ORDER 2010

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

- 1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment) (Humberstone Gate) (No.78) Order 2010, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 19<sup>th</sup> July 2010.
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
  - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
  - (i) In Schedule 1 to the Principal Order revoke the existing Schedule relating to:-

**Humberstone Gate** 

(ii) In Schedule 1 to the Principal Order insert the Schedule hereto in appropriate alphabetical order

relation to contraventions committed before the commencement of this Order.

# **SCHEDULE**

# **HUMBERSTONE GATE**

Part 100	One Way Street from its junction with Gallowtree Gate to its junction with Charles Street in that direction
Part 102	Prohibited Right Turn from Humberstone Gate into Rutland Street
Part 109	Prohibition of Entry into the eastbound carriageway from the westbound carriageway at a point 15 metres west of its junction with Vestry Street
Part 127	Prohibition of entry and driving at any time all motor vehicles except permit holders and except loading Sunday to Friday 5am-11am Saturday 5am to 9am from its junctions with Gallowtree Gate to its junction with Charles Street

# North Side

- Part 233 from its junction with Gallowtree Gate to its junction with Charles Street
- Part 204 from its junction with Charles Street to a point 41 metres southwest of its junction with St James Street
- Part 304 from a point 41 metres south-west of its junction with St James Street to a point 6 metres south-west of its junction with St James Street
- Part 501 from a point 41 metres south-west of its junction with St James Street to a point 6 metres south-west of its junction with St James

# Street

Part 204 from a point 6 metres south-west of its junction with St James Street to its junction with Wharf Street South including the pedestrian area

# South Side

- Part 204 from its junction with Rutland Street to its junction with Charles Street including the central reservation
- Part 501 the south Side of the central reservation from a point 33 metres south west of its junction with Vestry Street to a point 29 metres south west of its junction with Yeoman Street
- Part 233 from its junction with Charles Street to its junction with Gallowtree Gate
