

THE LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (KINGFISHER AVENUE AREA) (NO.93) ORDER 2011

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -


- 1. This Order may be cited as "The Leicester (Consolidation) Traffic Regulation Order 2006(Amendment)(Kingfisher Avenue Area) (No.93) Order 2011", and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 2nd day of May 2011.
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order insert the Schedule hereto in appropriate alphabetical order
- 4. The Council hereby revoke all the restrictions in the Leicester (Consolidation) Traffic Regulation Order 1975 ("the 1975 Order") and its subsequent amendments in so far as they impose restrictions on the following roads. Restrictions imposed by the 1975 Order on other roads will remain in force.

Heron Road

5. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

IN WITNESS whereof the Council have caused the Common Seal of the Leicester City Council to be hereunto fixed this 27th day of April 2011.

SCHEDULE

HERON ROAD

North-west Side

- from its junction with Kingfisher Avenue to a point 20 metres north-Part 207 east of its junction with Kingfisher Avenue
- Part 207 from a point 47 metres north-east of its junction with Kingfisher Avenue to its junction with Spinney Hill Road

South-east Side

Part 207 from its junction with Spinney Hill Road to its junction with Kingfisher Avenue

KESTREL CLOSE

East Side

Part 207 from its junction with Kingfisher Avenue to a point 61 metres south of its junction with Kingfisher Avenue

West Side

- Part 207 from a point 9 metres north of its southern extremity to a point 25 metres north of its southern extremity
- Part 207 from a point 38 metres north of its southern extremity to a point 48 metres north of its southern extremity
- Part 207 from a point 57 metres north of its southern extremity to its junction with Kingfisher Avenue

KINGFISHER AVENUE

North & East Side

- Part 207 from a point 53 metres south of its junction with Heron Road to a point opposite the centre of its junction with Kestrel Close
- Part 207 from a point 10 metres east of its junction with Sandpiper Close to its junction with Sandpiper Close

South & West Side

- Part 207 from its junction with Sandpiper Close to a point 8 metres east of its junction with Kestrel Close
- Part 207 from a point 37 metres east of its junction with Kestrel Close to a point 21 metres north of a point opposite the centre of its junction with Heron Road
- Part 207 from a point a point 4 metres south of a point opposite the centre of its junction with Heron Road to a point 14 metres south of a point opposite the centre of its junction with Heron Road
- Part 207 from a point 47 metres south of a point opposite the centre of its junction with Heron Road to a point 51 metres south of a point opposite the centre of its junction with Heron Road

SANDPIPER CLOSE

East Side

Part 207 from its northern extremity to a point 29 metres south of its junction with Kingfisher Avenue

West Side

- Part 207 from a point 8 metres north of its southern extremity to a point 48 metres north of its southern extremity
- Part 207 from a point 5 metres south of a point opposite the south side of its junction with Kingfisher Avenue to a point 4 metres north of a point opposite the north side of its junction with Kingfisher Avenue
