THE LEICESTER TRAFFIC REGULATION (BUS LANES) (AMENDMENT) ORDER 2011

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

- 1(i) This Order may be cited as "The Leicester Traffic Regulation (Bus Lanes Amendment) Order 2011" and shall come into force on the 25th November 2011
- 1(ii) For the purposes of this Order
 - "Emergency Service Vehicle" means a vehicle operated by the police, fire and rescue service or ambulance service responding to an emergency incident.
- The provisions of the principal Orders listed in Schedule 1 to this Order shall be amended to allow vehicles operated by Network Rail and Emergency Service Vehicles to operate within the conditions set out in Article 3.
- It shall not be a contravention to cause or permit any vehicle to be in, enter or proceed on any bus lane set out in the principle Orders provided that the vehicle is a vehicle being operated by Network Rail when responding to an incident on the rail network or an Emergency Service Vehicle responding to an emergency incident and that it is reasonably necessary for the vehicle to enter the bus lane.
- 4 Nothing in this Order shall affect the principle Orders in their operation in relation to offences committed prior to this Order coming into force.
- The definition of Emergency Service Vehicle contained in this Order amends the definition's given previously in the principle Orders and the above definition takes effect upon this Order coming into force.
