



**THE LEICESTER CITY COUNCIL**  
**THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER**  
**2006 (AMENDMENT) (GWENDOLEN ROAD) (NO.103) ORDER 2012**

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment) (Gwendolen Road) (No.103) Order 2012, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 13<sup>th</sup> February 2012
2.
  - (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
  - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
  - (i) In Schedule 1 to the Principal Order revoke the existing Schedules relating to Glebe Street and Gwendolen Road.
  - (ii) In Schedule 1 to the Principal Order insert the Schedule1 hereto in appropriate alphabetical order
  - (iii) In Section 3 of the Principal Order entitled Waiting Restrictions after part 234 insert Schedule 2 hereto
4. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

Part 215 from a point 10 metres north-west of its junction with Drinkstone Road to a point 43 metres south-east of its junction with Gedding Road

Part 207 from a point 43 metres south-east of its junction with Gedding Road to a point 43 metres north-west of its junction with Gedding Road

Part 207 from a point 5 metres south-east of its junction with Margaret Road to a point 5 metres north-west of its junction with Margaret Road

Part 207 from a point 7 metres south-east of its junction with Constance Road to a point 5 metres north-west of its junction with Constance Road

Part 231 from a point 5 metres north-west of its junction with Constance Road to a point 26 metres north-west of its junction with Constance Road

Part 207 from a point 6 metres south-east of its junction with Dorothy Road to a point 12 metres north-west of its junction with Dorothy Road

Part 207 from a point 7 metres south-east of its junction with East Park Road to its junction with East Park Road

#### Southern Side
