

LEICESTER CITY COUNCIL <u>THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006</u> <u>(AMENDMENT) (BARKBYTHORPE ROAD) (No.125) ORDER 2013</u>

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

- This Order may be cited as "The Leicester (Consolidation) Traffic Regulation Order 2006(Amendment) (Barkbythorpe Road) (No.125) Order 2013" and shall come into force on the 23rd January 2013.
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006".
 (ii) Any document referring to the Principle Order shall be construed as referring to the principle Order as amended by this Order.
- The Principle Order shall be amended as follows:
 (i) In Schedule 1 to the Principle Order revolve the state
 - (i) In Schedule 1 to the Principle Order revoke the existing schedules

Barkbythorpe Road

- (ii) In Schedule 1 to the Principle Order insert the Schedule hereto in appropriate alphabetical order.
- 4. Nothing in this Order shall affect the principle Order in its operation in relation to offences committed before the commencement of this Order.

SCHEDULE

BARKBYTHORPE ROAD

North-west Side

- Part 207 from its junction with Humberstone Lane to a point 20 metres north-east of its junction with Humberstone Lane
- Part 207 from a point 116 metres north-east of the property boundary line between numbers 41 and 43, Warren Drive to a point 241 metres north-east of the property boundary line between numbers 41 and 43, Warren Drive

South-east Side

- Part 207 from a point 244 metres north-east of a point opposite the property boundary line between numbers 41 and 43, Warren Drive to a point 30 metres north-east of a point opposite the property boundary line between numbers 41 and 43, Warren Drive, including the turning area and gated emergency access area associated with the width restriction feature on Barkbythorpe Road
- Part 207 from a point 15 metres north-east of its junction with Mountain Road to its junction with Humberstone Lane

KNIGHTWOOD ROAD

North-east Side

Part 207 from its junction with Barkbythorpe Road to a point 10 metres north-west of its junction with Barkbythorpe Road

South-west Side

Part 207 from a point 10 metres north-west of its junction Barkbythorpe Road to its junction with Barkbythorpe Road
