

LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) LUTTERWORTH ROAD) (No.137) ORDER 2013

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

- 1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment)(Lutterworth Road) (No.137) Order 2013" and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 11th September 2013.
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the Schedules relating to

 Lutterworth Road
 - In Schedule 1 to the Principal Order insert the Schedule hereto in appropriate alphabetical order
- 4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order.

Part 200	North-west Side from the City boundary to its junction with Middleton Street
Part 204	South-east Side from its junction with Wigston Lane to a point 160 metres south-west of its junction with Wigston Lane excluding the lay-by between 6 metres and 29 metres south-west of its junction with Wigston Lane
Part 224	The lay-by from a point 6 metres south-west of its junction with Wigston Lane to a point 29 metres south-west of its junction with Wigston Lane
Part 216	from a point 160 metres south-west of its junction with Wigston Lane to a point 181 metres south-west of its junction with Wigston Lane
Part 204	from a point 181 metres south-west of its junction with Wigston Lane to a point 188 metres south-west of its junction with Wigston Lane
Part 216	from a point 188 metres south west of Wigston Lane to a point 202 metres south west of its junction with Wigston Lane
Part 204	from a point 202 metres south-west of its junction with Wigston Lane to a point 18 metres south-west of its junction with Plantation Avenue
Part 216	from a point 18 metres south-west of its junction with Plantation Avenue to a point 50 metres north-east of its junction with Glenhills Way
Part 204	from a point 50 metres north-east of its junction with Glenhills Way to a point 50 metres south-west of its junction with Glenhills Way
Part 204	from a point 50 metres south west of its junction with Glenhills Way to the City Boundary
