

LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (HAVELOCK STREET AREA) (No.146) ORDER 2013

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

- 1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment)Havelock Street Area) (No.146) Order 2013" and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 16th December 2013
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the Schedules relating to

Baysdale Road Farndale Close Havelock Street Swindale Close Grisedale Close Martinsdale Close

In Schedule 1 to the Principal Order insert the Schedule hereto in appropriate alphabetical order

4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order.

North & West Side Part 200 from its junction with Havelock Street to a point 5 metres south-west of its junction with Havelock Street Part 207 from a point 5 metres south-west of its junction with Havelock Street to a point 4 metres north-east of its junction with Swindale Close Part 200 from a point 4 metres north-east of its junction with Swindale Close to a point 4 metres south- west of its junction with Swindale Close Part 207 from a point 4 metres south-west of its junction with Swindale Close to the boundary of Nos. 8/10 Baysdale Road Part 200 from the boundary of Nos. 8/10 Baysdale Road to a point 8 metres southwest of the boundary of Nos. 8/10 Baysdale Road Part 207 from a point 8 metres south-west of the boundary of Nos. 8/10 Baysdale Road to a point 8 metres south of the boundary of Nos. 24/26 Baysdale Road Part 200 from a point 8 metres south of the boundary of Nos. 24/26 Baysdale Road

South & East Side
Part 200 from its southern extremity to its junction with Havelock Street

to its southern extremity but excluding the parking bay between points 2

metres and 9 metres north of its southern extremity

SWINDALE CLOSE

Part 200	North-east Side from its junction with Baysdale Road to a point 7 metres north-west of its junction with Baysdale Road
Part 207	from a point 7 metres north-west of its junction with Baysdale Road to its north-west extremity including the turning head.
Part 207	South-west Side from its north-west extremity to a point 5 metres north-west of its junction with Baysdale Road
Part 200	from a point 5 metres north-west of its junction with Baysdale Road to its junction with Baysdale Road
FARNDALE CLOSE	
Part 200	North-east Side from its junction with Baysdale Road to a point 7 metres south-east of its junction with Baysdale Road
Part 207	from a point 7 metres south-east of its junction with Baysdale Road to its south-east extremity.
Part 207	South-west Side from its south-east extremity to a point 7 metres south-east of its junction with Baysdale Road
Part 200	from a point 7 metres south-east of its junction with Baysdale Road to its junction with Baysdale Road
GRISEDALE CLOSE	
Part 200	North Side from its junction with Martindale Close to a point 4 metres west of its junction with Martindale Close
Part 207	from a point 4 metres west of its junction with Martindale Close to a point 9 metres west of the boundary of Nos. 12/13 Grisedale Close
Part 200	from a point 9 metres west of the boundary of Nos. 12/13 Grisedale Close to its western extremity

South Side

- Part 207 from its western extremity to a point 3 metres west of its junction with Martindale Close
- Part 200 from a point 3 metres west of its junction with Martindale Close to its junction with Martindale Close

HAVELOCK STREET

Part 100 One Way Street from its junction with Jarrom Street to its junction with Walnut Street in that direction

North-east Side

Part 200 from its junction with Walnut Street to its junction with Jarrom Street

South-west Side

- Part 200 from its junction with Jarrom Street to its junction with Walnut Street excluding the lay by between 87 metres & 42 metres north east of its junction with Walnut Street
- Part 215 the lay by between 87 metres and 42 metres north east of its junction with Walnut Street

MARTINDALE CLOSE

North & West Side

- Part 200 from its junction with Havelock Street to a point 3 metres south of its junction with Grisedale Close
- Part 207 from a point 3 metres south of its junction with Grisedale Close to a point 43 metres south of its junction with Grisedale Close
- Part 200 from a point 43 metres south of its junction with Grisedale Close to a point 27 metres east of the boundary of 33/34 Martindale Close
- Part 207 from a point 27 metres east of the boundary of 33/34 Martindale Close to a point 10 metres west of the boundary of Nos. 27/28 Martindale Close
- Part 200 from a point 10 metres west of the boundary of Nos. 27/28 Martindale Close to its western extent including the turning head

South & East Side

Part 200 from its western extent including the turning head to a point 2 metres west of the boundary of Nos. 25/26 Martindale Close

- Part 207 from a point 2 metres west of the boundary of Nos. 25/26 Martindale Close to a point 2 metres east of the boundary of Nos. 14/15 Martindale Close
- Part 200 from a point 2 metres east of the boundary of Nos. 14/15 Martindale Close to a point 65 metres south of its junction with Grisedale Close
- Part 207 from a point 65 metres south of its junction with Grisedale Close to a point 7 metres north of the boundary of Nos. 1/2 Martindale Close
- Part 200 from a point 7 metres north of the boundary of Nos. 1/2 Martindale Close to its junction with Havelock Street
