THE LEICESTER (CHURCH STREET & COLTON STREET (PART))  
(TEMPORARY) TRAFFIC REGULATION ORDER 2014

WHEREAS THE LEICESTER CITY COUNCIL acting under powers delegated under Part 3 of its Constitution to the Director Regeneration, Transport and Highways is satisfied that all traffic in the roads described below should be temporarily restricted or prohibited by reason that works are being executed on, or near the road, or by reason of the likelihood of danger to the public or of serious damage to the highway.

NOW THEREFORE the Leicester City Council in exercise of its powers contained in Section 14(1) of the Road Traffic Regulation Act 1984 and all other enabling powers, hereby makes the following Order:-

- (1) This Order shall come into operation on the 20 January 2014 and may be cited as the Leicester (Church Street & Colton Street (part)) (Temporary) Traffic Regulation Order 2013.
- (2) The Interpretation Act 1978 shall apply for the interpretation of the Order as it applies for the interpretation of an Act of Parliament.
- (3) Nothing in this Order shall prevent at any time access for vehicles to any premises situated on or adjacent to those lengths of road or any other premises accessible from, and only from, those lengths of road.
- (4) Subject to Section 15 of the Road Traffic Regulation Act 1984, this Order shall cease to have effect when the said works have been completed.
- (5) Prohibit waiting, loading and unloading (both sides)  
Driving of motor vehicles:  
Prohibit the driving of motor vehicles in a northerly direction (Introduce "One-Way" system towards Charles Street  
Prohibit waiting, loading & unloading:  
**Church Street** – from the junction with Charles Street to the junction with Colton Street (its entirety)  
Pedestrian access will be maintained at all times
- (6) Suspend the existing "One-Way" order allowing a two-way traffic flow  
**Colton Street** – from the junction with Rutland Street to the Junction with Church Street (its entirety)  
(Traffic marshal in attendance 0700hrs to 1700hrs for delivery vehicle manoeuvres)  
Prohibit waiting, loading and unloading:  
**Colton Street** – from the junction with Rutland Street for a distance of 25 metres
