THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006
(AMENDMENT) (LOCAL ENVIRONMENTAL WORKS 2 – EILEEN AVENUE
AREA) (No.168) ORDER 2015

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006(Amendment) (Local Environmental Works 2 – Eileen Avenue Area) (No.) Order 2015, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 20th April 2015.
2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
(ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principle Order revoke the existing Schedules relating to

Egerton Avenue
Sudeley Avenue
 - (ii) In Schedule 1 to the Principal Order insert Schedule 1 hereto in appropriate alphabetical order
4. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

Part 207 from a point 7 metres north-east of its junction with Belle Vue Avenue to a point 7 metres south-west of its junction with Belle Vue Avenue

Part 207 from a point 6 metres north-east of its junction with Eileen Avenue to a point 6 metres south-west of its junction with Eileen Avenue

Part 207 from a point 10 metres north-east of its junction with Byford Road to its junction with Byford Road

South-east Side

Part 207 from its junction with Byford Road to a point 10 metres north-east of its junction with Byford Road

Part 207 from a point 10 metres south-west of its junction with Sudeley Avenue to its junction with Sudeley Avenue

EILEEN AVENUE

North Side

Part 207 from a point 6 metres west of its junction with Egerton Avenue to its junction with Egerton Avenue

South Side

Part 207 from its junction with Egerton Avenue to a point 6 metres west of its junction with Egerton Avenue

SUDELEY AVENUE

North Side

Part 207 from a point 13 metres west of its junction with Abbey Lane to its junction with Abbey Lane

South Side

Part 207 from its junction with Abbey Lane to a point 10 metres west of its junction with Abbey Lane

Part 207 from a point 10 metres east of its junction with Egerton Avenue to a point 10 metres west of its junction with Egerton Avenue

Part 207 from a point 3 metres east of its junction with Tollemache Avenue to its junction with Tollemache Avenue

TOLLEMACHE AVENUE

South-east Side

Part 207 from its junction with Sudeley Avenue to a point 2 metres south-west of its junction with Sudeley Avenue

Part 207 from a point 4 metres north-east of its junction with Welbeck Avenue to its junction with Welbeck Avenue

WELBECK AVENUE

North Side

Part 207 from its junction with Tollemache Avenue to a point 2 metres east of its junction with Tollemache Avenue

Part 207 from a point 5 metres west of its junction with Egerton Avenue to its junction with Egerton Avenue

South Side

Part 207 from its junction with Egerton Avenue to a point 6 metres west of its junction with Egerton Avenue
