THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (AYLESTONE VILLAGE) (No.174) ORDER 2015

Leicester City Council (the Council) in exercise of their powers under Section 1 and 2 of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

- This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Aylestone Village) (No.174) Order 2015 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on Thursday 27th August 2015.
- 2. (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the existing Schedules relating to

Disraeli Street Granby Road

- (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order.
- 4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

SCHEDULE 1

DISRAELI STREET

Part 100 One Way Street from its junction with Granby Road to a point 118 metres south-west of its junction with Granby Road in that direction.

North-west side

Part 231 from its junction with Granby Road to its junction with Old Church Street.

South-east side

- Part 231 from its junction with Hall Lane to a point 101 metres south-west of its junction with Granby Road.
- Parl 231 from a point 71 metres south-west of its junction with Granby Road to a point 55 metres south-west of its junction with Granby Road.
- Part 207 from a point 35 metres south-west of its junction with Granby Road to its junction with Granby Road.

GRANBY ROAD

Part 100 One Way Street from its junction with Aylestone Road to its junction with Disraeli Street in that direction.

North-east Side

Part 231 from its junction with Disraeli Street to its junction with Aylestone Road.

South-west Side

- Part 231 from a point 59 metres north-west of its junction with Aylestone Road to a point 52 metres north-west of its junction with Aylestone Road.
- Part 504 from a point 52 metres north-west of its junction with Aylestone Road to a point 8 metres north-west of its junction with Aylestone Road.
- Part 207 from a point 8 metres south-east of its junction with Disraeli Street to its junction with Disraeli Street.
