TEMPORARY TRAFFIC REGULATION ORDER
SECTION 16A OF THE ROAD TRAFFIC REGULATION ACT 1984 (RTRA 1984) AS AMENDED
BY THE ROAD TRAFFIC REGULATION (SPECIAL EVENTS) ACT 1994
THE LEICESTER (VAISAKHI) (ORDER) 2016

1. Leicester City Council makes this Order in exercise of its powers under section 16A of the RTRA 1984 and any other enabling powers over the following areas of the highway being:-

Prohibit the driving of all vehicles at any time between 1000 hours and 1600 hours on Sunday 24th April 2016 on the following sections of highway:

Great Central Street: From the junction with Vaughan Way to the junction with All Saints Open.

Vaughan Way (Northbound Slip road): Between its junctions with St Nicholas Circle and Great Central Street.

St Nicholas Circle: Between its junctions with St Nicholas Place and Vaughan Way.

Peacock Lane: Its entirety.

St Martins: Its entirety.

Grey Friars: Its entirety.

Berridge Street: Its entirety.

Millstone Lane: Between its junctions with Pocklingtons Walk and Horsefair Street.

Horsefair Street: Its entirety.

Halford Street: Between its junctions with Charles Street and Horsefair Street.

Charles Street: Between its junctions with St Georges Way and Halford Street.

St Georges Way: From the junction with Swain Street to the junction with Charles Street.

Swain Street: From the junction with Sparkenhoe Street to the junction with St Georges Way.

Sparkenhoe Street: From the junction with St Peters Road Road to the junction with Swain Street.

St Peters Road: From the junction with East Park Road to the junction with Sparkenhoe Street.

East Park Road: From the junction with St Saviours Road to the junction with St Peters Road.

East Park Road: From the junction with Green Lane Road to the junction with St Saviours Road.

Each restriction will be lifted once the procession has moved on to the next section.

2. The Order is made to facilitate the Vaisakhi event.
3. The Order shall come into operation at 1000 hours on Sunday 24th April 2016 and will remain in force until 1600 hours on Sunday 24th April 2016.
4. While the Order is in operation, traffic, including bicycle movement along the highway specified in paragraph 1 will be temporarily restricted (except for emergency access) as detailed in paragraph 1.
5. All restrictions will be signed and will remain in force only for as long as is necessary.
6. Nothing in the Order will apply to:
 - Anything done with the permission of or at the direction of a police officer.

- Any vehicle being used for police, fire brigade or ambulance purposes, or the purposes of a statutory undertaker in an emergency, such as the loss of supplies of gas, electricity or water to premises in the area, which requires vehicles to be brought onto a section of highway to which the Order applies.
7. Any vehicles parked in contravention of a restriction contained in this order is at risk of being towed if the vehicle is not removed following a PCN being issued.
