THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (BRAUNSTONE GATE AND HIGHCROSS STREET) (No.196) ORDER 2016

Leicester City Council (the Council) in exercise of their powers under Section 1 and 2 of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

- This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Braunstone Gate and Highcross Street) (No.196) Order 2016 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 10 June 2016.
- 2. (i) The expression "the Principal Order" means "the Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order revoke the existing Schedules relating to

Braunstone Gate Highcross Street

- (ii) In Schedule 1 to the Principal Order insert Schedule 1 to this Order in the appropriate alphabetical order.
- In section 3 of the Principal Order entitled Waiting Restrictions after part 244 insert schedule 2 hereto
- 5. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

- Part 204 from a point 157 metres south-east of its junction with Cumberland Street to its junction with Cumberland Street

West Side

- Part 204 from a point opposite its junction with Cumberland Street a point 157 metres south-east of a point opposite its junction with Cumberland Street
- Part 200 from a point 157 metres south-east of a point opposite its junction with Cumberland Street to a point 75 metres north-west of its junction with High Street
- Part 202 from a point 75 metres north-west of its junction with High Street to a point 14 metres north-west of its junction with High Street
- Part 308 from a point 14 metres north-west of its junction with High Street to a point 2 metres north-west of its junction with High Street
- Part 200 from a point 2 metres north-west of its junction with High Street to its junction with High Street
