THE LEICESTER TRAFFIC REGULATION ORDER (BUS LANE AND BUS GATE)
ORDER 2011 (AMENDMENT) (No 4) (HAYMARKET BUS STATION) ORDER 2015

Leicester City Council (the Council) in exercise of their powers under Section 1 and 2 of the Road Traffic Regulation Act 1984 (The Act) and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

1. This Order may be cited as The Leicester Traffic Regulation Order (Bus Lane and Bus Gate) Order 2011 (Amendment) (No4) (Haymarket Bus Station) Order 2015 and shall be included amongst the Orders which may be cited as The Leicester Traffic Regulation (Bus Lane and Bus Gate) Order 2011 and shall come into force on 23 February 2016
2.
 - (i) The expression "the Principal Order" means "The Leicester Traffic Regulation (Bus Lane and Bus Gate) Order 2011"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order insert Schedule 1 hereto in the appropriate alphabetical order.
 - (ii) In Schedule 2 to the Principal Order insert Schedule 2 hereto in the appropriate alphabetical order.
4. Nothing in this Order shall affect the Principal Order in its operation in relation to contraventions committed before the commencement of this Order

Schedule 2

1. The Council hereby revoke the restrictions contained in Section 3A of the Leicester Traffic Regulation (Bus Lane) (Charles Street) Order 1995 as amended.
2. The Council hereby revoke the restrictions contained Section 3 of the Leicester Traffic Regulation (Bus Lane) (Abbey Street/St Augustines Road/Duns Lane Order 1995 in so far as they relate to Abbey Street.
3. All other restrictions imposed by the Leicester Traffic Regulation (Bus Lane) (Charles Street) Order 1995 and the Leicester Traffic Regulation (Bus Lane) (Abbey Street/St Augustines Road/Duns Lane) Order 1995 remain in force.
