

# LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (ONYX CRESCENT) (No.202) ORDER 2016

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 32, 45, 46 and 49 of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order: -

- This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Onyx Crescent) (No.202) Order 2016, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 25<sup>th</sup> of July 2016
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"as amended.
  - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
  - (i) In Schedule 1 to the Principal Order revoke the existing Schedule's relating to:

#### **Humberstone Lane**

- (ii) In Schedule 1 to the Principal Order insert Schedule 1 hereto in the appropriate alphabetical order.
- 4. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.

Part 207	from a point 74 metres north of a point opposite the southern property boundary of no 291 Humberstone Lane to a point 71 metres south-east of ia point opposite the southern property boundary of no 291 Humberstone Lane
Part 207	from a point 15 metres north-west of a point opposite the north-west side of its junction with Claymill Road to its junction with Barkbythorpe Road
Part 200	from its junction with Barkbythorpe Road to its junction with Thurmaston Lane
West Side	
Part 200	from its junction with Troon Way to a point 12 metres north-west of a point opposite the north-west side of its junction with Barkbythorpe Road
Part 207	from a point 12 metres north-west of a point opposite the north-west side of its junction with Barkbythorpe Road to a point 74 metres north of the southern property boundary of no 291 Humberstone Lane
Part 207	from a point 8 metres south of a point opposite the south-west side of its junction with The Roundway to a point 15 metres north of a point opposite the north-west side of its junction with The Roundway
Part 207	from a point 10 metres south of its southern junction with Onyx Crescent to a point 10 metres north of its southern junction with Onyx Crescent
Part 207	from a point 10 metres south-east of its northern junction with Onyx Crescent to a point 10 metres north-west of its northern junction with Onyx Crescent

## **ONYX CRESCENT**

Inner Side

Part 207 from its southern junction with Humberstone Lane to a point 10 metres west of its southern junction with Humberstone Lane

Part 207 from a point 20 metres west of its southern junction with Humberstone Lane to a point 29 metres west of its southern junction with Humberstone Lane

Part 207 from a point 25 metres south-west of its northern junction with Humberstone Lane to its northern junction with Humberstone Lane

### Outer Side

- Part 207 from its northern junction with Humberstone Lane to a point 10 metres south-west of its northern junction with Humberstone Lane
- Part 207 from a point 29 metres south-west of its northern junction with Humberstone Lane to a point 37 metres south-west of its northern junction with Humberstone Lane
- Part 207 from a point 29 metres west of its southern junction with Humberstone Lane to its southern junction with Humberstone Lane
