

# LEICESTER CITY COUNCIL THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006 (AMENDMENT) (FOX STREET AND CAMPBELL STREET) (No.238) ORDER 2017

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under sections 1, 2, 32, 35, 45, 46, 46A, 47, 48, 49, 51, 53 and 63A of the Road Traffic Regulation Act 1984 ("the 1984 Act") and of Part IV of Schedule 9 to the 1984 Act and of all other enabling powers including the Road Traffic Act 1991 as amended (whether generally or in relation to the area of the Council) ("the 1991 Act") and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the 1984 Act hereby make the following Order:-

- 1. This Order may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Fox Street and Campbell Street) (No 238.) Order 2017, and shall be included among the Orders which may be cited as the Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into force on the 6th November 2017
- 2. (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006" as amended.
  - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
- 3. The Principal Order shall be amended as follows:
  - (i) In Schedule 1 to the Principle Order revoke the existing Schedules relating to

## Campbell Street Fox Street

- (ii) In Schedule 1 to the Principal Order insert Schedule 1 hereto in appropriate alphabetical order
- 4. In Schedule 3 of the Principal Order after Section 3 paragraph 12 insert Schedule 3 hereto
- 5. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order.
