THE LEICESTER (CONSOLIDATION) TRAFFIC REGULATION ORDER 2006
(AMENDMENT) (BELVOIR DRIVE) (No.292) ORDER 2020

Leicester City Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 9, 32, 35, 45, 46, 46A, 47, 48, 49, 51, 53 and 63A of the Road Traffic Regulation Act 1984 ("the Act") and of Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby make the following Order:-

1. This Order may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 (Amendment) (Belvoir Drive) (No.292) Order 2020 and shall be included amongst the Orders which may be cited as The Leicester (Consolidation) Traffic Regulation Order 2006 and shall come into operation on the 6th day of July 2020.
2.
 - (i) The expression "the Principal Order" means "The Leicester (Consolidation) Traffic Regulation Order 2006"
 - (ii) Any document referring to the Principal Order shall be construed as referring to the Principal Order as amended by this Order.
3. The Principal Order shall be amended as follows:
 - (i) In Schedule 1 to the Principal Order insert Schedule 1 hereto in the appropriate alphabetical order.
 - (ii) In Schedule 3 of the Principal Order after paragraphs 14. insert Schedule 2 hereto
4. The Council hereby revoke all the restrictions in the Leicester (Consolidation) Traffic Regulation Order 1975 ("the 1975 Order") and its subsequent amendments in so far as they impose restrictions on Belvoir Drive. Restrictions imposed by the 1975 Order on other roads will remain in force.
5. Nothing in this Order shall affect the principal Order in its operation in relation to contraventions committed before the commencement of this Order

Belvoir Drive

North-east side

- Part 207 from its junction with Aylestone Road to a point 15 metres south-east of its junction with Aylestone Road

South-west side

- Part 207 from a point 15 metres south-east of its junction with Aylestone Road to its junction with Aylestone Road

EXPLANATORY NOTE

(this does not form part of the Order)

The effect of this Order is to make permanent a part 207 (no waiting at any time) parking restriction that was previously introduced under The Leicester (Belvoir Drive) (Experimental) Traffic Order 2019 on either side of Belvoir Drive at its junction with Aylestone Rd and to make an administrative adjustment relating to the Traffic Regulation Order for Coleman Road contained in the 2006 Consolidation Traffic Regulation Order
